CANOE TRIP NOTICE - DOE RIVER

(Scheduled: Sat. May 4, 1985) The section of the Doe we will be running is mostly Class II. The put in is near Hampton High School and take out near Elizabethton. This section is rather technical and requires considerable maneuvering. Plan to meet at Mc Donalds in Elizabethton at 9:00 a.m. Pre-registration is requested. Call Dave Ingram at 282-5856 (Johnson City) or at 245-7171. Those pre-registered will be notified in case there is a change of plans.

HIKE NOTICE - SPURLOCK CAVE HIKE LEADER: GREG KRAMER
(Scheduled: Sat. May 11, 1985) Meet at Building 215 parking area (T.E.C. Personnel Building) at 9:30 a.m. on Saturday May 11. Bring lunch, change of clothes and water. Helmet and helmet mounted light are also required, these can be supplied by the trip leader if notified prior to the trip. Spurlock's passages are mostly walking passages but there is water at times in the lower passages. For the more adventuresome person there are alternate routes above the water. CANOE TRIP NOTICE - NOLICHUCKY RIVER (BELOW UNAKA SPRINGS) LEADER: G. TUSTIN (Scheduled: Sat. May 11, 1985) Class II. We will canoe the section of the Nolichuckey River below Unaka Springs. This is a very popular section of the river and is excellent for novice paddlers who have the desire to advance from Class I to Class II whitewater. Bring proper safety equipment, lunch, and beverage. Plan to meet at the Building 215 parking lot at 8:30 a.m. Due to variable water levels, preregistration is required. HIKE NOTICE - LITTLE STONEY CREEK FALLS

(Scheduled: Sat. May 11, 1985) In north Scott County Virginia Little Stoney Creek tumbles over two falls as it passes through a rugged gorge. From the USFS Hanging Rock Recreation Area near Dungannon we will follow a gently graded trail for four miles (while gaining 900 ft.) to the upper end of the gorge and have lunch on Bear Rock. Bear Rock affords an expansive view of the gorge and surrounding ridges. A small variety of purple rhododendron will be in bloom on the cliffs as well as several other early-blooming wild flowers in the gorge and on the ridges. Meet at the B-215 parking lot at 7:45 a.m. for an 8:00 a.m. departure. Driving time to Dungannon is approximately one hour. Bring lunch, water, raingear, and an extra sweater or light jacket. Expect to return to Kingsport by 5 p.m. This hike is rated easy-to-moderate (rating=2). This is a joint hike with the State of Franklin Group of the Sierra Club. HIKE NOTICE - AT-HUGHES GAP TO CARVERS GAP LEADER: STEVE BANKS (Scheduled: Sat. May 18, 1985) This portion of the A.T. follows the Tennessee - North Carolina state line from Hughes Gap up a ridge to the summit of Beartown Mountain, down somewhat to Ash Gap, up the ridge again to Cloudland, over Roan High Knob (6258 ft.), and down to Carvers Gap, for a total distance of 4.6 miles. The first 2.6 miles has an

elevation gain of over 2100 feet (that's steep, folks). The first half of the hike is difficult, and the second half easy, making the whole hike moderate (?). Meet at the Tennessee Eastman Personnel Building (Building 215) on Lincoln Street in Kingsport at 8:00 a.m., or at the main Johnson City post office at 8:30a.m. Bring a lunch, water, sturdy boots or shoes, and clothing suitable for the weather.

CANOE TRIP NOTICE - TOE RIVER

(Scheduled: Sat. May 18, 1985) The section of the Toe River that we will paddle is Class II for the most part. Toward the end of the run there is a lengthy section of continuous white water (Class II and/or III at sufficient water lever) that is the highlight of the trip. The put in will be at the N.C. 80 bridge in Mitchell Co. and the take out will be at the N.C. 197 bridge near Red Hill. This is an excellent river for the intermediate paddler. Bring food, water, clothing suitable for the weather conditions, and normal safety equipment. Plan on approximately 10 hours to complete the trip including travel both ways. We will meet at the Colonial Heights Burger King at 8:00 a.m. Please pre-register with Earl Brown, Building 54D or 239-6696.

HIKE NOTICE - NANTAHALA MOUNTAINS BACKPACK (Wallace Gap to Wesser) LEADER: KEVIN EDGAR (Scheduled: May 25-27, 1985) This will be a challenging (31 miles), especially beautiful backpacking trip which will have many climbs and descents and will cross eight balds, ending (or beginning) at the Nantahala River. We will sleep in tents, and those who wish to will share 2 suppers and 2 breakfasts. It is likely (but unsure at press time) that we will have 2 groups hiking the route in opposite directions. The route, if there is only one group, will be South to North (Wallace Gap to Wesser). It was also uncertain at press time whether we would drive down on Friday night (staying at a motel in the area Friday night) or Saturday morining. We will share gear (tents, stoves, cooking gear) as much as possible. Preregistration is required, and the total number of hikers will be limited, so please register as soon as possible. yards of sidehill relocation to move this section of trail out of the creek bottom. This
