# **Scheduled Activities and Trip Reports**

Hike: A.T., Mt. Rogers Headquarters (Va. 16) to I-81, January 1

Leader: Neil Dotson, 423-245-6105, Rating: Medium

On this 11.5-mile section of the A.T. in SW Virginia, we will climb over Brushy, Locust and Glade Mountains (all a little under 4000 feet) - not too bad given that we'll start at 3220 feet at the Headquarters. After that first 6 miles, we will drop down to walk through open meadows for the last nearly 3 miles of the trail and cross the Middle Fork of the Holston. Given the length of trail and the short daylight hours, we'll meet at the usual spot (between Burger King and McDonalds in Colonial Heights) for a 7:30 a.m. departure. This trail is Y2K compliant; please ensure that you are seasonally compliant by dressing appropriately (with plenty of layers), having good waterproof footwear, and bringing a nice big lunch to keep you warm.

### Backpack Trip Report: Naked Ground, October 23-24

Three of us, Emmett Dougherty, Arvell Luttrell, and Garry Luttrell, drove to Beech Gap, at the N.C. / Tenn. stateline, on the Cherohala Parkway between Tellico Plains, Tenn. and Robbinsville, N.C. to begin our overnight backpack trip, hiking on the Stratton Bald Trail to the campsite at Naked Ground. When we stopped for lunch at Stratton Bald, some other hikers told us of Boy Scouts camped at our destination. Sure enough, when we arrived we found that there were three troops there, so we picked out a campsite almost out of hearing distance. We listened to the Tenn. / Ala. football game while trying to stay warm around the campfire. During the night our water bottles froze; and, when we awoke, there was evidence of snow flurries on our tents. Then, when we got to the car, one of the larger Boy Scout troops was boarding their bus for a return trip to Birmingham, Alabama. Round trip hiking distance was 9 miles, with very little change in elevation.

# Hike Report: A.T., So. Fork Holston (Va. 670) to Mt. Rogers National Recreation Area Headquarters (Va. 16), October 30

This hike along Brushy Mountain - yes, *the* Brushy Mountain, not any of those pale imitations found elsewhere - was taken by Neil Dotson, Freda Kuo, Bill Stowell and Ed Oliver. It was a pleasant fall day, a little past the peak in colors - with walking in cool hollows early in the hike and the long stretch of ridgeline hiking on Brushy Mountain (which does live up to its name). There were a few slight views of Rye Valley and the land to the north, but otherwise it's woodlands hiking - probably a

letdown for some after the broad expanses of Whitetop and the Mt. Rogers area. But it's a different kind of beauty, one greatly enjoyed by the four. The hike was capped off by a look at the impressive shelter located near the headquarters, and driving back through some back lanes rather than on Va. 16 to Marion.

### **Hike Report: Hiltons Fire Tower, November 13**

# A.T. Section Maintenance and Special Projects

October 22, 31, Trail Maintenance - Steps Near Carvers Gap

On October 22 my son, William J. Fritsch accompanied me. We poured the concrete footings for a set of steps just south of the Carvers Gap parking lot. We also set up the cross members and frame for the steps. During the following week Ed Sacksteder and I completed steps except for minor grading and one cross piece. Began some minor grading and installation of three water bars to stabilize the bank above the steps. The steps were well used, and received compliments from five groups of hikers who had been on the trail for at least one night.

### October 29, Meeting with New Watauga District Ranger

Emphasis on the Elk River relocation was made for the next approval after the Roan relocation package. Joe McGuiness indicated he was close to getting his part done for Roan Mountain, Round Bald, and Grassy Ridge and would send it to the Cherokee Office for a final public review and OK (probably will be complete before Jan). Candace seemed very receptive to listening and working through issues directly with her if we needed to discuss any USFS issues that she could assist us with. Total: 4 hours.

### November 3, Install Waterbars Between Watauga Dam And Watauga Lake Shelter Ed Oliver reporting

Frank Williams and Ed Oliver installed about a half dozen waterbars on the section of the Appalachian Trail between Watauga Dam and Watauga Lake Shelter. Total: 16 hours.

We did not have the key to the gate so the wood for the shelter floor for the Boy Scout Eagle project had to be carried 2 miles to the shelter. We had to make additional trips to get the tools. ### November 16, Flag Relocations On Campbell Hollow Relo

We wanted to see if there was any reason to put the Elk River relocation on the ridge on the north side of Jones Branch so that hikers might be able to see Jones Falls. We also inspected the Campbell Hollow relocation. We flagged two modifications to the Campbell Hollow relo. Both of these flag lines were at steep places on the original relo. We judged that the path up the ridge at Jones Branch is too steep. We may do one more trip in this area in the near future. Ben inspected the open areas along the Elk River. Total: 55 hours.

# **November 20, Erosion Control Maintenance with ASU Students, Trip #3** *Bill Stowell reporting*

This was the third work trip with Appalachian State University students. We met at 19E and hiked in above Apple House Shelter to install water bars and some other erosion control in the area. ### November 27, Roan Mountain, Carvers Gap to the Cloudland Hotel Site

My son, William J. Fritsch and I cut blowdowns and inspected general trail conditions in order to plan future work trips. As we descended from the Cloudland Hotel site we confirmed the bad weather report. There were pools of water everywhere, and thawing ice added to a heavy surface accumulation. Many drainage ditches were working fine, but others were blocked, and we cleared what we could. We need to consider setting some logs in place in several of the low lying areas to help hold back erosion and keep a steady drainage from allowing large muddy spots to form. There were at least a dozen places where drainage was inadequate. The newly installed water bars were largely intact, and the upper trail section presented no problems. Total: 6 hours.
