TEHCC Appalachian Trail (A.T.) Committee Open to Interested Parties

The A.T. Committee is a sub-committee of TEHCC that facilitates issues regarding TEHCC's 127 mile Trail Section from Spivey Gap, North Carolina to Damascus, Virginia. The committee meets about 6-8 times per year in the evenings at the Eastman Employee Center and focuses primarily on A.T. projects, formal decisions, plans and responses to a number of issues with the Appalachian Trail Conference (ATC) and the United States Forest Service (USFS). Most projects discussed relate to trail relocations, bridge construction projects, and shelter repair/maintenance. The committee provides an opportunity for participants to make valuable contributions to comprehensive planning and to learn how the cooperative agreement between the ATC, trail maintaining clubs and USFS works together to manage the A.T. for everyone to enjoy hiking and backpacking while conserving the natural, scenic, historical, and cultural resources of the trail. So if you're interested in learning about trail maintenance, stewardship or how the cooperative process works, you are welcome to join the committee. Funds Available for First Aid Training for A.T. Maintainers

Funds are available for A.T. maintenance volunteers to seek training for First Aid/CPR Training. ATC has offered clubs limited funding to certify volunteers by reimbursing club members for the cost of certified courses in First Aid and CPR. Last year we organized a class through the American Red Cross in Kingsport for about ten members. This year we would like to encourage all trail

volunteers interested in the training opportunity to sign up to take classes at a time that meets their convenience. Classes are conducted at the American Red Cross in Kingsport at a variety of times. So if you would like to receive the training this year, you can contact the American Red Cross to sign up for any class that has an opening that fits your schedule. Since funding is limited, we would like to limit the full reimbursement to about 10-12 people this year. Introductory Whitewater School 2000

The 29th annual "Canoe School", sponsored by the Tennessee Eastman Hiking and Canoeing Club in association with the Appalachian Paddling Enthusiast's (APEs), will be held June 8th, 10th, and 11th. The school is targeted for beginner and novice solo and tandem whitewater canoeists and kayakers,

and consists of an evening of lecture and videos plus two days on the water. As in the past there will continue to be a strong emphasis on river safety. Participants will be responsible for providing their own gear and transportation.

Minimum required gear: Whitewater canoe w/ one paddle per paddler plus one spare per boat and helmet, or a whitewater kayak w/ paddle, sprayskirt and helmet. One PFD (life jacket) per person. Canoes should have bow and stern lines. All boats must have air bags. Rain jacket. Knee pads. Lunch. Change of clothes in a waterproof bag.

Hike Notice: Guest River Gorge, Saturday, March 11, 2000, M-D

This is a hike along a Rails-to-Trails old railroad grade beside the rushing Guest River between Coeburn, Virginia and the Clinch River. There are a number of pretty and interesting sandstone

cliffs, some with coal beds, that border the trail. If we go all the way to the Clinch River, the round trip is 12 miles but since it is in and back, the trip is only as far as we want to go; the grade is always easy, and the footway nice and even. A.T. Section Maintenance and Special Projects

February 11, Section 20, Spivey Gap to Temple Hill

Bill Berry reporting

I worked from Spivey Gap over to Temple Hill. Since then we have had some high winds, so I plan to go again on 2/26/00. 8 Hours.

February 22, Section 19, Indian Grave Gap

Ed Oliver Reporting

Ed Oliver, Frank Williams, Bill Elderbrock

3 people X 8 hours = 24 person-hours

Summary: Ed Oliver, Frank Williams, and Bill Elderbrock worked on trail rehab, digging 400 ft of trail from Indian Grave Gap going south. There is more repair needed. Also checked the place where the power lines cross the trail, trail north of Indian Grave Gap. There are no larger trees in that area. It will be years before any problem needs attention in this area.

February 15, 2000, Section 16, Iron Mountain Gap

Ed Oliver, Ben Lawhon, Bob Peoples, Bill Elderbrock, Darrol Nickels, Frank Williams 6 people X 9 hours = 54 person-hours

Summary: Ed Oliver, Ben Lawhon, Bob Peoples, Bill Elderbrock, Darrol Nickels, Frank Williams went north from Iron Mountain Gap to do some additional clearing in the apple orchard. The spring in this area was improved and the trail to the spring was blue blazed. The brush was piled for the students from Asheville who will be coming at the end of the month to work on this clearing project. Also Ed looked at a possible relocation from the orchard going trail south. The workers met two thru-hikers heading north who started in Georgia in January. They got to Spence Field in the Smokies and bypassed the rest of the Smokies because of three feet of snow.

February 13, 2000, White Rocks Fire Tower

4 people X 11 hours = 44 person-hours

Summary: We drove to Hampton and hooked up with Bob Peoples who drove us up to the White Rocks Fire Tower. Ed and Frank worked on flagging around the fire tower area. Bob and I cut blow downs first going trail north from the tower to near the overlooks and then back to within 1 mile of Moreland Gap Shelter.

February 9, 2000, Section 8, Watauga Dam Road to Shook

Summary: Ed Oliver, Bruce Cunningham, Bill Elderbrock, Frank Williams, Darrol Nickels cut blowdowns from Watauga Dam Road to Shook Branch. The shelter was found to be in good condition. Bruce picked up trash in the area of U.S. 321. The group also walked up towards the wilderness boundary and cut 4 trees in the power line area and blowdowns up to the wilderness boundary. The group of five spent 8 hours on this effort.

February 19, 2000, Section 9, Hampton Trail Head to Pond Flats

8 people X 9 hours = 72 person-hours

Summary: We met at the parking area near Shook Branch. Bob Peoples, Kevin O'Donnell, Kireina Bell, and Ajay Kalra drove to the Hampton trail head and started cutting trees where the blue blaze intersects the A.T. and headed up towards Pond Flats. Mike Floyd, Ed Oliver, Frank Williams, and Bill Stowell headed trail south from Shook Branch towards Pond Flats cutting blowdowns. All the blowdowns are currently cleared on this section.

February 19, 2000, Section 19, Indian Grave Gap

4 people X 7 hours = 28 person-hours

Summary: The group of: Bruce & Mary Cunningham, Phyllis Cairnes, and Mary Ellen Ress, drove to Indian Grave Gap and lopped growth going trail south to the side trail before rain got the best of them.

February 4, 2000, Pond Mountain Inspection

Today, the four of us went to inspect land, bought, and to be bought for the A.T. We looked at five tracts in a row on the north side of the A.T. on the west end of Pond Mountain as the trail comes up out of Laurel Fork gorge, heading north. Status of the tracts, from west to east, is as follows:

- 1. FS is working on a swap with a lakeside tract. This will probably go through.
- 2. Optioned. Will be bought soon.
- 3. Already bought.
- 4. Changed from Priority 2 to 3. This means this tract will not be condemned. This was the biggest decision of the day. The Trail can be relocated for a length of maybe 500 feet to get away from this tract if necessary, but this will probably not have to be done.
- 5. Priority 3. Okay to leave it that way.

Trip time for Ray and Darrol was six hours.
