

Introductory Whitewater School 2000

The 29th annual "Canoe School", sponsored by the Tennessee Eastman Hiking and Canoeing Club in association with the Appalachian Paddling Enthusiasts (APEs), will be held June 8th, 10th, and 11th. The school is targeted for beginner and novice solo and tandem whitewater canoeists and kayakers,

and consists of an evening of lecture and videos plus two days on the water. As in the past there will continue to be a strong emphasis on river safety. Participants will be responsible for providing their own gear and transportation.

Minimum required gear: Whitewater canoe w/ one paddle per paddler plus one spare per boat and helmet, or a whitewater kayak w/ paddle, sprayskirt and helmet. One PFD (life jacket) per person. Canoes should have bow and stern lines. All boats must have air bags. Rain jacket. Knee pads. Lunch. Change of clothes in a waterproof bag. **Schedule:** June 8th Lecture and films 6:00 - 9:00 PM



Putnam Mine Locates Near Appalachian Trail in Roan **Highlands**

TEHCC recently learned of the operation of a gravel quarry located in Avery County, N.C. between Cranberry and Minneapolis along U.S. 19E. The quarry has been in operation for several months and was brought to the attention of the club through ATC and a number of people in the local community. The A.T. is only two miles from this mine as it traverses the wide open grassy bald on the east flank of Hump Mountain. As hikers walk from the summit of Hump Mountain down hill to Elk Park, N.C., they head directly toward the mine site for approximately one mile, 20-30 minutes of the average hiker's time. The proximity of the mining site to the Appalachian Trail and the unobstructed view of the open pit mine from the trail during all seasons from the balds area is of concern to the A.T. community.

The owner of this quarry has completed the permit process for this mine and the first phase development is in full operation. It is our understanding that some infrastructure development has taken place but mining has not yet begun. The current operation involves about 16 acres of disturbed area and the proposed permitting will allow up to 156 acres. The duration of the project is anticipated to be a very long time - > 50 yrs.

On March 16, a public meeting was held in Newland, N.C. due to a large public outcry to the attorney general of N.C., about the lack of communication to the public and other organizations, since they had no opportunity to comment on this mining project prior to North Carolina granting the initial permits for its construction. Most of the people who addressed a review committee (> 90%) were against the operation of the mine due to its visual impact and close proximity to neighboring property owners and their homes. Since no one was given the opportunity to comment before the issue of the permits, a majority of the people asked the Department of Environmental and Natural Resources (DENR) to revoke or suspend the permit until further comment could be made from the public. Other organizations wanting to consider protecting the viewshed of the A.T. followed suit including ATC, NPS, NPCA, TEHCC and SAHC. There is some merit to this request as there are requirements for such public meetings as required by the N.C. Mining Act of 1971, and the N.C. Appalachian Trails System Act. A finding in which a significant adverse effect on the purpose of a publicly owned park, forest, or recreation area (in this case, the Appalachian National Scenic Trail) as stated in the N.C. Mining Act and the N.C. Appalachian Trail Systems Act may cause the DENR to reconsider their initial decision.

The DENR is currently reviewing the information gathered at the meeting and will most likely render a decision in 2-4 weeks as to whether the mining permit will be allowed to stay, be suspended temporarily or be revoked.



Special Patch for Thru Hikers

During the summer of 1999, members of the Tennessee Eastman Hiking and Canoeing Club (TEHCC), which has responsibility for maintaining 127 miles of the Appalachian Trail as it crosses northeastern Tennessee, began to recognize that more and more thru hikers and long distance hikers had been taking a few hours off from their hikes to help TEHCC maintain their section of the A.T. One of the suggestions was to award a special patch to thru hikers and long distance hikers who are willing

to thru hikers and long distance hikers who are willing to show their support of the A.T. by working on trail maintenance. This idea was discussed in June of 1999 while TEHCC maintainers were working with the Konnarock Crew on a reroute near Doll Flats in the

Cherokee National Forest. Two Konnarock members, sisters who had thru hiked in 1998 with their mother and three siblings as "the family", volunteered to design something special. Marty Allen ("the artist") designed and Sara Allen ("Rosey") lettered a "Hiker-Trail Volunteer" patch depicting a crossed crosscut saw and mattock superimposed over Laurel Fork Falls, which is located in the Pond Mountain Wilderness Area.

TEHCC was pleased with the design, and when the final 1999 manpower statistics showed that thirty thru hikers and long section hikers had contributed 159.5 hours of trail maintenance, they went ahead and placed an order for the six-color fabric patches. Beginning with the 2000 hiking season, any thru hiker or long section hiker who is willing to work for eight hours on trail maintenance under the supervision of a TEHCC maintainer will be entitled to receive one of these unique patches. In fact, the first two patches have already been awarded. These went to 2000 thru hikers Ron Batchelor ("Seiko") and Bob Sylvester ("The Slyman"). With this kind of start, TEHCC may have to order more patches before the year is out!

Summary: The Orchard at Weedy Gap

Bob Peoples and Darrol Nickels met twelve Warren Wilson College students at Iron Mountain Gap. We proceeded north on the A. T. for about one and a half miles to the "Orchard near Weedy Gap". There we cleared away brush that had been cut on previous trips, repainted the blue blazes to the spring, and used a pole saw to remove dead and broken limbs from the upper reaches of some trees. Purpose: Repair treadway and clip growth trail south of Indian Grave Gap

Total person-hours: $5 \times 8 = 40$

Summary: On February 26, Bruce and Mary Cunningham clipped back the rhododendron and other growth for about a half mile starting about 1.5 miles trail south of Indian Grave Gap. John Thompson, Frank Williams, and Ed Oliver continued the treadway repair trail south of Indian Grave Gap. We repaired about 300 feet of trail. We also improved a vista about 0.5 miles trail south of Indian Grave Gap. We will need one more trip to complete the treadway repair on this section of trail.

February 29, 2000 - Section 11 - Dennis Cove Road to Bitter End

Purpose: Complete flagging of trail relocations on White Rocks Mountain

Number of People: 2 (Ed Oliver, Bob Peoples)

Total person-hours: 2 X 10 = 20

Summary: On February 29 Ed Oliver and Bob Peoples completed flagging a relocation at White Rocks Fire Tower. Also trail at the Canute Place was adjusted to make it easier to follow. Also the blue blaze to the spring was painted and the spring cleaned out.

March 1, 2000 - Section 2 - McQueens Gap to Backbone Rock Trail Junction

Participants: Ed Oliver, Bruce and Mary Cunningham, Bill Elderbrock, and Frank Williams

Hours: 11 ea. X 5 = 55 total

Summary: The clearing of blowdowns and significant rhodo clipping was carried out on Section 2 from McQueens Gap to Backbone Rock trail junction. About 12 large trees were cleared from this section. Two very large trees about 3 ft or more in diameter (Dick Burow Trees) were left but can be walked around, as these were too big for the small saw. One tree about 0.1 mi. trail south of the Backbone Rock trail junction needs to be finished up for a step. The group ran out of time cutting a wedge out, so hopefully this piece may be removed by an AX (maybe 10 minutes worth) or a chainsaw to finish it up.

March 4, 2000 - Section 12 - Elk River area

Purpose: Check out private purchase of land in Elk River area

Number of People: 2 (Ed Oliver, Bill Stowell) Total person-hours: 2 people X 6 hours = 12

Summary: Ed Oliver and Bill Stowell Drove to Elk Falls to check into a proposed property purchase of land near where the relo will come down Jones Branch and then left along the Elk River. The proposal is for four structures to be built so as to minimize the impact on the A.T. The owners would like to get an easement on most of the property to protect the area from further development and of course a tax break for themselves. We felt that this is doable and will work with them to provide protection for the A.T.

March 4, 2000

Bob Spencer was on a fun hike with friends from Low Gap south to Cross Mountain by Double Springs Shelter and spent some time in maintenance during the walk. Bob carried out two bags of litter, mostly from the shelter. The shelter area is still not clean but Bob was not equipped to do anymore. He was especially upset to find people had been drinking whiskey and leaving their bottles there. He also did casual clipping and removing winter debris from the trail. He noted that cattle are using the trail area from south of the shelter almost to Hwy 91. Bob said this makes very messy walking. Please give Bob Spencer credit for 8.0 hours trail maintenance.

March 5, 2000 - Section 19 - Curley Maple Shelter

Purpose: Trail Rehab and Lopping

Number of People: 4 (Bruce & Mary Cunningham, Ed Oliver, Bill Stowell)

Total person-hours: $4 \times 9 = 45$

Summary: Bruce & Mary Cunningham clipped from the side trail to Curley Maple Shelter. Ed Oliver and Bill Stowell completed the trail rehab between Indian Grave Gap and the side trail. This section is now in great shape.

March 7, 2000 - Section 2 - Backbone Rock Trail Junction to Abingdon Gap Shelter

Purpose: Cut blowdowns

Number of People : 2 (Dick & Suzanne Burow)

Total person-hours: 2 X 7 = 14

Summary: Dick & Suzanne Burrows went in to cut 2 larger blow downs that had been reported from an earlier trip. Between Backbone Rock Trail and Abingdon Gap Shelter, they cut three 8-12 inch blow downs and two 36 inch diameter blowdowns.

March 8, 2000 - Section 11 - Dennis Cove Road to Bitter End

Purpose: Cut blowdowns

Number of People: 3 (Bob Peoples, Seiko, Slyman)

Total person-hours: 3 X 7 = 21

Summary: Bob Peoples, and thru hikers (Seiko, Slyman) drove to Bitter End and went trail-north cutting blowdowns. One large blowdown consisting of 2-3 poplar trees had a large root ball that made a hole in the trail. The trail was repaired.

March 8, 2000 - Sections 17 & 18 - Iron Mountain Gap to Indian Grave Gap

C. B. Willis reporting

Worked entire trail from Iron Mountain Gap to Indian Grave Gap

Purpose: Routine Spring maintenance

Total person-hours: 18 people x 8 hours = 144

Work accomplished:

- 1. Checked entire trail.
- 2. Clipped growth.
- 3. Cleared winter debris and small blowdowns. We will return to Low Gap, 150 yards north, to clear two large blowdowns, as we didn't carry chainsaws today.
- 4. Picked up litter on trail and at shelter.
- 5. Replaced the journal at the shelter and removed the old one (I will give it to TEHCC at the dinner on 3/17.)
- 6. Picked up litter at Iron Mountain Gap, the A.T. crossing of USFS 230, at Beauty Spot and at Indian Grave Gap.
- 7. Replaced water signs at Deep Gap and "Walking Trail Only" signs at Iron Mountain Gap and

- Indian Grave Gap.
- 8. We need a new sign for Indian Grave Gap, listing distances to Beauty Spot, Cherry Gap Shelter, and Iron Mountain Gap. The sign placed last year has been stolen.
- 9. Freshened blazes and removed redundant markings from above Deep Gap to Beauty Spot. We now need to do this from Beauty Spot to Indian Grave Gap and from the top of Unaka Mountain south to the Deep Gap switchback.
- 10. The biggest job today was reworking the springs on the north side of Unaka Mountain. They flow all over the trail. We have made it better by taking out the old rusted iron pipe and replacing it with a 12' plastic pipe. There are so many springs here it is hardly possible to prevent some of the excess flow on the trail. The new pipe assures a good steady flow of water sufficient to fill water bottles easily. We made a great improvement but this is a problem we will have to live with. It really isn't much of a problem anyway.
- 11. It appears we need to do aggressive trail rehab for about 1/2 mile on the north side of Unaka Mountain. We will schedule this later.

March 8, 2000 - Section 20 - Nolichucky River to Spivey Gap

Purpose: Spring Maintenance

Number of People: 3 (Bruce Cunningham, Bill Elderbrock, Ed Oliver)

Total person-hours: $3 \times 7 = 21$

Summary: This is Craig Haire's section from Chestoa to Temple Hill Gap. Craig is on a 10 month hike so Bruce Cunningham, Bill Elderbrock, and Ed Oliver went to do normal maintenance for Craig in his absence. Ed reported this section was in excellent shape. They did cut some blow downs, did some clipping, and painted blazes.

March 15, 2000 - Section 12 - Elk River Area

Bill Stowell reporting

Purpose: Review private purchase of Elk River Property with USFS

Number of People : 3 (Ed Oliver, Derrick Stowell, Ray Hunt)

Total person-hours: $3 \times 6 = 18$

Summary: Ed Oliver, Derrick Stowell, and Ray Hunt met Kathy Ludlow, Landscape Architect with the USFS and Dwayne Stutzman, Regional Trails Specialist with the Division of Parks and Recreation for North Carolina to look at the property purchase on the Elk River near where the new A.T. relocation will come down Jones Branch to the Elk River. The proposed property owners are looking to get a property easement to protect the area. The group concluded this is feasible with some attention to landscaping, house design, and colors. Also an additional short section was flagged along a rock face just past the site where an old picnic shelter is located along the river.

March 18, 2000 - Section 4 - U.S. 421 to Tenn. 91

Purpose: Spring Maintenance

Number of People: 3 (Steve Falling, Bryan Shackelford, Neil Dotson)

Total person-hours: 3 X 8 = 24

Summary: We worked on the above section, clearing blowdowns and making pre-emptive strikes on greenbriars, as well as hauling out some trash (not too bad) and putting some brush at both ends of the southern relo to make it clearer where the trail goes (there were double blazes but virtually no brush to further reinforce the point). There was only one blowdown that really requires a chainsaw that we couldn't handle. It is approximately 2.5 miles from U.S. 421, and we carved on X on it. Is there the possibility that someone can take care of this? A longer term issue is a section of significant sidehill slough just before reaching the shelter. One other issue: about 1-1/4 mile from U.S. 421 (just as you get to the skirting of the cleared field) is what Steve Falling said was a non-standard sign indicating water down a trail toward Shady Valley. Is this mentioned in the trail quide?

March 18, 2000 - Section 12 - Walnut Mountain Road to Campbell Hollow Road

G. S. Luttrell reporting

Total person-hours: $6 \times 8 = 48$

Miles: 3.5

Six of us - Bill Elderbrock, Collins Chew, Bob Harvey, Chester Bruner, Charles Beggerow, and Garry Luttrell - clipped, blazed, and cleared blowdown from Walnut Mtn. Road to Campbell Hollow Road, on a sunny, cool day. We blazed in both directions, and left one 18 in. stepover blowdown, about .5 mi. from Walnut Mtn. Road.

March 18, 2000 - Section 13

Purpose: Cut blowdowns and repair trail Doll Flats to 19E

Number of People : 2 (Bob Peoples, Seiko)

Total person-hours: 2 X 9 = 18

Summary: Bob Peoples and Seiko started at Doll Flats. Two 24 inch beech trees were cut in this area. Continued cutting blowdowns hiking towards 19E until they ran out of gas (for the chain saw that is). Worked some where a large oak root ball pulled the trail out on the new relocation section leaving a 4 foot deep by 14 foot long hole in the trail. Further repair is needed.

March 18, 2000 - Section 15

Purpose: Cut blowdowns from Hughes Gap to the top of Roan High Knob

Number of People: 2 (Mary Cunningham, Ed Oliver)

Total person-hours: 2 X 10 = 20

Summary: Mary Cunningham and Ed Oliver cut blowdowns and clipped from Hughes Gap north to the top of Roan High Knob.

March 18, 2000 - Section 16

Purpose: Cut blowdowns from Iron Mountain Gap to Greasy Creek Gap Number of People: 3 (Frank Williams, Kevin Odonnell, Ajay Kalra)

Total person-hours: $3 \times 9 = 27$

Summary: Frank Williams, Kevin Odonnell, and Ajay Kalra drove to Iron Mountain Gap and cut blow downs reported by a thru hiker to Greasy Creek Gap.

March 18, 2000 - Section 16

Purpose: Cut blowdowns from Greasy Creek Gap to Hughes Gap

Number of People: 3 (John Thompson, Bill Stowell, Derrick Stowell)

Total person-hours: 3 X 10 = 30

Summary: Mary Cunningham dropped off John Thompson, Bill Stowell, and Derrick Stowell at the gate on the road to Greasy Creek Gap. We cut blowdowns, clipped, and refreshed some blazes from there to Hughes Gap.

March 21, 2000

Ed Oliver reporting

Purpose: Repair trail south of U.S. 19E and choose privy site at Yellow Mountain Barn

Number of People: 6 (Bruce Cunningham, Bob Peoples, and Ed Oliver from TEHCC, Seiko and

Mr. Boo (thru hikers), and Lee Thompson from USFS)

Total Person-hours: $5 \times 8 = 40$

Summary: Bruce met Lee Thompson and selected several privy sites at the Yellow Mtn Barn. We now have permission to install the privy whenever we can. Bruce found out that the Forest Service has an Older Americans Crew that picks up trash at the barn on a regular basis. Bruce suggested and they agreed to put one or two drums at the shelter for trash. The rest of us worked on repairing the 14 foot section of trail on the newly relocated trail south of 19E. A tree fell and the root ball took out the trail. We built a crib wall and filled behind it with rock and soil. Two hikers reported that there are at least six trees down between Roan High Knob and Carvers Gap.
