# Volunteer Opportunities on the Appalachian Trail

TEHCC proudly maintains 135 miles of the Appalachian National Scenic Trail from Damascus, Virginia to Spivey Gap in North Carolina. This huge task is only possible because of our dedicated volunteers. Currently our 135 miles of trail is divided into 34 maintenance sections varying in length from about 1 mile to 7 miles. We always have a need for volunteers to take a trail section. We have recently lost a couple of section maintainers, so some of these sections currently lack a maintainer. Section maintainers are responsible for painting blazes, trimming back yearly growth, cutting weeds, cleaning waterbars, and cutting out blowdowns. It would be wonderful to have more maintainers so we could increase the number of sections and reduce the length of some sections. Projects that are too large for the section maintainers are handled by special crews, so no one ever has to take on a project larger than they are comfortable with.

It isn't even necessary to wield a Pulaski, scythe or saw to participate. How about monitoring one of our sixteen shelters? Shelters are a popular hike destination, so how about doing a little maintenance while you are there? Currently, maintenance of most of our sixteen shelters is assigned to whoever has responsibility of that trail section. In order to reduce the work load of the section maintainer, it is highly desirable for a person or group of people to act as shelter monitors and to check on the shelter several times during the hiking season. Some tasks for the shelter monitor include: checking for leaks and the general condition of the shelter, log book replacement, minor trash pickup, checking the water source condition, etc. If any condition is found that the shelter monitor cannot correct, other volunteers can be called upon to help fix the condition.

### For the Record

#### Friday Hikers: Looking Glass Rock, September 30, 2011

The Looking Glass Rock hike was great, sunny, 70°. The trail climbed about 1,700 feet in just over three miles, 6.5 miles roundtrip, which took us 5 hours with plenty of rest stops and a long leisurely lunch at the top. I would call it a strenuous hike. The first mile or so started off following a stream with some small cascades along the way. The trail here was wide, with a gentle grade and smooth walking surface. The next mile or so was a series of switchbacks up the mountain. The trail had narrowed to one-person wide, but the surface was still good. After about two miles the trail reached a flat rock area which is used as a helicopter pad by the local rescue squad for injured rock climbers. This was our spot for lunch #1. A spur trail past the helipad led to Lower Looking Glass Cliffs which provided excellent views of the mountains. We ran into a local and without him guiding us we would have never found the spur trail. From there to the top, the trail was, for me anyway, extremely strenuous due to many natural made steps ranging six inches to two feet high. Roots crossed the trail and the clay dirt past each root on the downhill side had eroded out by water flowing down the trail. The trail had narrowed significantly, was rocky (both small and large), and was steep (straight up, nary a switchback). This part of the trail took us through tunnels of rhododendron and mountain laurel. Once we reached the summit, the trail started going down steep (huh!). But just a few feet down the trail, we came out in the open on top of the big cliff. The view of the mountains from both the lower and upper cliffs was outstanding. Up on the mountains above us we could see a couple of little spots of the Blue Ridge Parkway. After we got back down, we drove up to the Parkway and out to the Looking Glass overlook. From there we could see the entire dome and the cliffs we had been on earlier. The Parkway roundtrip, driving and looking, took about an hour and a half (plenty of looking time and rest). Once we got back down to the bottom, we decided to go over to DuPont Park. Round trip it took us one hour. There had been an old DuPont plant there, hence the name of the park. The old plant site is still fenced off; it's hard to say what contamination is there. Steve had hiked there before. There are many waterfalls there, some short-walking distance and some intermediate distances. Steve said all trails were in good shape. It seemed strange to have so many waterfalls in what seemed to be pretty flat country. Starting and ending the drive to DuPont we found an excellent ice cream stand and had milk shakes. I had one going and coming. I'm addicted to chocolate milkshakes; can't have just one. The drive from Kingsport to the trailhead took us two hours, with excellent roads from the interstate to the trailhead. We left Kingsport at 8 and got back at 8. We took our time and piddled a lot. Hey, we're retired. Ate at Burger King on the way home. Hikers were Steve Kasten and Larry Miller.

#### Friday Hikers: Roan High Knob, October 7, 2011

We had beautiful weather for our hike over Roan High Knob on the AT, 5.8 miles with several new relocations and the side trip to the shelter and mountain summit. Several switchbacks have been added to improve the trail between Hughes Gap and the old Hotel site. Several more are planned, but we measured it as it is now to improve accuracy of next year's AT Data Book. I was startled to see full leaf color at mid-elevations and bare trees above about 5,500 feet. #### Elk Knob, October 8, 2011

"O suns and skies and clouds of June
And flowers of June together
Ye cannot rival for one hour
October's bright blue weather"

Although June is a great time to hike, especially when azalea and rhododendron are blooming, as this first stanza of Helen Hunt Jackson's poem indicates, it's hard to beat a pretty fall day. We were far from the only people who've discovered North Carolina's new Elk Knob State Park, not far north of Boone. The new trail of 1.8 miles to the summit has been completed, and features great views from two overlooks, one looking north and one south. From the southern view on our clear day it was easy to pick out Mt. Mitchell and the Black Mountains, almost 50 miles away. The 1000' climb is easy to moderate (at most) thanks to skillful trail design and intensive construction, using gravel over geotextile as we've used on Round Bald. The fall colors were brilliant on the drive over Holston and Iron Mountains, less so on Elk Knob. Elk Knob at 5560' elevation is dominated by a beech forest, and beech just turns kind of brown. Club members are encouraged to hike this trail, with spring flowers in early May and azalea and Gray's lilies in mid-June providing good seasons in addition to fall. Our hikers included first-timer Monika Wiedmann, Serita Blankenbecler, Donna Ashby, and Joe DeLoach.

**Summary:** TEHCC held the Fall partnership meeting with ATC and the USFS in Unicoi on October 12<sup>th</sup>. TEHCC shared progress made on trail projects for 2011. In 2011 we had a record of 13,486 maintenance hours for the fiscal year. We discussed some of the projects undertaken this year with Konnarock, ASU students and Hardcore. The relo work on Beartown Mountain up to Cloudland is slow going; we'll use Konnarock time through at least 2012. The Round Bald gravel project went well this year; ASU students helped move 37 tons of gravel by buckets. Next year we'll need about 80 tons to complete the portion from Carvers Gap to the top of Round Bald. Overuse on top of Round Bald continues to be a problem with visitors walking off the trail. The plan for now is to not gravel any areas but the AT, even though visitors will likely continue to walk in areas where rare plants may be found. Increased education for visitors (maybe signs near Carvers Gap) needs to be considered to minimize wandering off the desired path (on-going discussions with SAHC and others).

There are 3 relos in the process of being approved for work in 2012: (1) Nolichucky relo, (2) Backbone Rock Trail, and (3) White Rocks (field work done, just needs to be written up). The USFS expects these to be approved in Spring 2012. TEHCC will likely do the Noli work in winter with Club labor and Backbone Rock with ASU in the Fall. A relo proposal soon to come from TEHCC to the USFS will bundle a proposal near Turkey Pen Gap and an area near TN 91. TEHCC had an Eagle Scout install a pole to store food at Watauga Lake shelter; we need to check the shelter log to see if this has reduced bear activity at the shelter. The Koonford bridge design was discussed based on a more recent design supplied by Lynn DiFiore (1935 design, locust ok). TEHCC lost the connection to the volunteer who expressed interest in this project from two years ago. We agreed to form a committee to prepare for the stages of specifying the design, materials, and labor (maybe contract) and providing a cost estimate (committee of Morgan, Lynn, Matt, Ed, and one other TEHCC member). TEHCC has a long-term shelter plan to renovate shelters, to repair them due to natural wear and tear, fix issues with design, and enlarge to accommodate a few more people. The new design will be more native or natural looking compared to cinder block materials from the 1960s. We also discussed the option of removing some shelters due to their declining state and/or proximity to the next nearest shelter or road. A request for consideration by TEHCC would need to go to the USFS and ATC to propose action/alternatives.

A significant problem with hikers (not sure whether thru-hikers or section hikers or whom) using the Roan bathrooms has resulted in massive over-use and in some cases plumbing problems when hikers have disconnected drain lines to take showers. Also, problems are occurring with hikers sleeping on tables and in bathrooms. A long-term plan to reduce inappropriate use by hikers is needed – perhaps thru signage, info in guidebooks/website message boards, etc, and or consideration of a Ridgerunner will help provide education/communication. The Osborne tract is slated for gravel with funds from ATC available this year. TEHCC can store gravel dumped near the old house site so that gravel can be dispersed either this fall or next spring. TEHCC can also get materials from USFS to complete accessible stile changes to install a swing gate.

We discussed open areas and prescribed burns. A review will be held with John Odell to look at recommendations for mowing open areas in 2012. Can Lot is the only burn on TEHCC section that might have an impact in 2012. Another burn is planned for area south of Bitter End, but this area has had burns previously. TEHCC and the Appalachian Ranger District will investigate rehab or reconstruction of fencing on Hump Mountain since more stimulus funds are available for balds management in Bradley Gap and on Hump. We are expecting funds from the TNLP will be available in 2012. The grant amounts are still to be determined by ATC. The USFS has requested we update the Sponsored Voluntary Services Agreements with maintaining clubs working on the AT. We have an existing agreement on file with the districts that will need to be updated by the end of the year. We also need to include JHA with our outings for maintenance sign-up forms.

Next meeting is March 14, 2012. Action Items:

- 1. TEHCC to send in FY reports to district rangers
- 2. USFS to complete write ups for Noli, Backbone Rock, and White Rocks relo for approval by Spring of 2012
- 3. Form committee for Koonford Bridge project committee of Morgan, Lynn, Matt, Ed, and one other TEHCC member
- TEHCC to submit proposals for shelter renovations/removal to ATC and USFS as needed
- 5. USFS, TEHCC and ATC to explore options for hiker education to reduce impact on Round Bald and facilities at Roan Mountain
