## Relocation of Backbone Rock Trail with ASU



The Watauga Global Community College of Appalachian State University (ASU) offers their incoming freshmen an optional orientation event to get acquainted with each other. For the twelfth consecutive year they have partnered with Tennessee Eastman Hiking and Canoeing Club (TEHCC) to do a trail maintenance event! Trail maintenance in groups provides many social opportunities in a work environment. On this Friday August 17, we started the first relocation of the Backbone Rock Trail just south of Damascus. Ninety seven students and five professors of Watauga College showed up in spite of a 70% prediction of rain (which did not materialize). And very importantly we had 17 club members and friends who helped acquaint the students with trail digging.

The trail relocation was about a half mile in from parking lot. We were somewhat unprepared for the many rocks encountered. Many were just under the duff. But everyone preserved within their physical capabilities to make a new trail. Except for a couple of random bee stings, we had a great day. Probably we completed the equivalent of about 1000 feet of trail. This first relocation totals over 2500 feet. 120 people put in 1085 hours.

I took advantage of one of the guided tours for the Highland Festivals to take a trip on the Clinch. The trip was led by Clinch Valley Outfitters. Although, I used my own kayak, I wish I had paid the extra \$5 and used their equipment – less work getting there and getting out. I was impressed with the selection and quality of their kayaks. The river was high that day and very few rocks except at the put-in which was close to Fort Blackmore. We stopped several times for Bill to talk about how the diversity of the eco-system or specific historical events with an opportunity to get out and walk a bit if needed. Bill was raised in Scott County and loves sharing his knowledge of the ecosystem and the history surrounding the Clinch Valley. People: Joe DeLoach, Ted Mowery, Carl Fritz, Mike Hupko, Paul Benfield, Bob Peoples, Ed Oliver, Vic Hasler, Tim Stewart, Steve Perri Summary: The AT Committee met to discuss project plans, grants, work logistics, upcoming meetings, training, and opportunities for replacing people who are rotating out of positions. We have one more week of Konnarock (8/11 and 8/12) for work trail-south of Cloudland. Next year we have four weeks assigned, but will consider donating one week if another trail club really needs one. We have submitted a Konnarock project for 2017 for Cross Mountain, but we may need to submit a BE for the USFS separately. We have a large project with ASU on Aug 17<sup>th</sup> working on Backbone Rock blue-blaze trail. We will not be cutting vertical trees in this relo. Working with the USFS, we will assist NC rescue orgs to identify access routes to the AT for emergencies. We'll also work with the USFS and ATC to get their input/recommendations for hospitals nearest to various road crossings for future projects. Hard Core in 2013 will be working on White Rocks Mountain one day and on Cloudland the next day. Bob Peoples offered his hostel for overnight accommodations. We reviewed our list of grant-funded projects and are working to reconcile remaining payments for reimbursements. We will provide recommendations to ATC through the Southern Regional Office for projects to fund in 2013. Our priority would be to have a Ridgerunner or Naturalist for the Roan Mtn area. We deferred doing Cherry Gap Shelter rehab another year. We would recommend consideration of funds in 2013 to purchase materials for the Koonford Bridge, but we think it will take more than a year to align the design and contract for supervision (maybe Dave Hardy of VTATC). Vic Hasler and Kim Peters will be attending the ATC Leadership Workshop in Shepherdstown, 8/10-8/12. They were provided with funds to attend through ATC. We are discussing with AT partners the proposal for TEHCC to turn over maintenance responsibilities from the VA state line into Damascus to simplify interactions. Planning for the biennial meeting at WCU in 2013 is ongoing. Joe reported progress on getting ideas, contacts and commitments for workshops. He has about 42 workshops in 7 tracks committed, out of a target of 72 workshops. We made a list of agenda items for the partnership meeting on Oct 17<sup>th</sup>. Abingdon is the next nearby town to be designated as an AT Trail Community (Sept 11). We reviewed the trail reports for trail conditions due to recent storms bringing down trees. We need to assess impacts of blowdowns and growth of weeds. The committee agreed to use Mark Wenger's visit during the Fall dinner meeting, Oct 19<sup>th</sup>, for recognition of ATC's 75th anniversary. This year is TEHCC's 65<sup>th</sup> year of AT responsibility. We discussed the idea of purchasing T-shirts; synthetic shirts seem more popular than cotton. We have needs to ID a new field editor for the guidebook (to gather mileage, GPS and other data) to replace Collins and a new person to replace Joe on the RPC.

Recently, we received notification that the family of Dawn Cope requests that TEHCC help gather notations from shelter logbooks written by Dwight and Dagan Cope who drowned in Laurel Falls on July 4th. According to their trip plan, they hiked from Spivey Gap to Laurel Falls between June 26 and July 4th. Anyone who may be able to hike in and gather the logbooks or take a photo of their entries, please gather the info and turn it in to Steve Perri or Vic Hasler. Their trail names were Whitey (father) and Red Headed Stranger (son). The shelters we need data from are: No Business Knob, Cherry Gap, Curley Maple Gap, Clyde Smith, Roan High Knob, Stan Murray, Overmountain, Mountaineer Falls, and Moreland Gap.
