### From the Chair


#### Vic Hasler, Steering Committee Chair

A two year work-in-progress, the <u>TEHCC Trail Wiki</u> currently offers information (directions to the trailhead, description, and photos) on nearly 80 places. During 2012, TEHCC partnered with the "Mission Possible" program offered by Eastman Wellness. A series of Sunday afternoon hikes were arranged during the summer and fall to enjoy the shorter trails. This Mission Possible program is going to be held again in 2013. It is starting a bit earlier in March and continuing through November. ### **Proposed TEHCC Maintenance Section Change**

TEHCC was recently asked by the Mount Rogers Appalachian Trail Club (MRATC) to turn over our maintenance responsibility to MRATC for the 4.5 miles of the A.T. from the VA state line into Damascus. Since 1947, TEHCC has had the assigned responsibility for maintenance from Spivey Gap, NC to the center of Damascus, VA. After much discussion and consideration with our A.T. cooperative Trail partners and internal discussions within TEHCC, we believe that transition of section maintenance responsibilities to MRATC would simplify responsibilities, interactions and perceptions associated with this section of Trail and we have agreed to let MRATC take over this 4.5 mile section of trail.

In 2005, ATC adopted a different structure to manage the A.T., from governance by a group called the board of managers to the regional partnership committees (RPC's) that are in place today. Because of this change, TEHCC now reports in through two RPC's rather than to one, as is the case for most trail maintenance clubs. The northern-most 4.5 miles of TEHCC's section is reported to the Virginia mid-Atlantic Region (VARO) and the remaining 134 miles is reported to the Southern Region (SORO). So currently, TEHCC has the complexity of coordinating activities and communications with government agencies within VA, TN, and NC. While the status quo of continued maintenance of this entire section would have been fine for the club to handle, the changes in our interactions within the new structure of ATC adds another level of complexity. Relinquishing the responsibilities in VA will simplify our reporting responsibilities.

Both regional offices of ATC have been informed of our decision. The VARO RPC now has the responsibility to approve this transfer since this change will bring additional land within VARO RPC's jurisdiction. We expect the approval decision to occur in the spring of 2013.

### **2013 Environmental Monitoring and Management**

ATC is preparing for another season of environmental monitoring on the A.T. and is looking for help from the Trail maintaining clubs. In the spring, there will be at least one workshop to train volunteers in rare plant monitoring and phenology monitoring. The workshops will teach the most current protocols and provide necessary materials for volunteers to independently monitor along the A.T. There will also be various projects scheduled to control invasive exotic plants in the Trail corridor. Most of these projects will occur in the summer months, but there will be some manual/mechanical control work done in February to remove kudzu and multiflora rose from the Charlie Johnson and Bishop Hollow tracts between Highway 19E and Buck Mountain Rd. That work is tentatively scheduled for February 9, and/or Feb. 13-16, and/or Feb. 20-23.

Other potential opportunities include training workshops for using GPS and documenting invasive exotic plants on the Trail. These trainings will only occur if there is enough interest from volunteers to warrant the exercise. Depending on the geographic location of those interested, the training may be held as a webinar allowing people to participate from the comfort of their own homes.

## **Great Smoky Mountains NP Permit Fee**

Beginning February 13, 2013, people staying overnight in the Great Smoky Mountains NP (GRSM) backcountry will be subject to a \$4/person/night permit fee. A.T. thru-hikers will be charged \$20, with the permit good for 38 days. A GRSM backcountry permit can be obtained up to 30 days in advance. Thru-hikers will have 8 days to pass through the GRSM. Thru-hiker permits will be available year-round.

Thru-hikers will be able to obtain permits on-line, by fax (once payment is made by phone) and in person at the GRSM Backcountry Office (BO) at the Sugarlands Visitor Center near Gatlinburg, TN. Credit cards will be accepted on-line, by phone and in person at the BO. Checks, money orders and cash will be accepted in person at the BO. Four bunks will be reserved in each GRSM A.T. shelter for thru-hikers March through May. Thru-hikers must always give up space in shelters to non-thru-hikers holding reservations. Ranger presence will be increased on the A.T. during thru-hiker season. For more information, please call 865-436-1297.

We completed rock fill work at a number of tree root exposures, started on a second major gully and built a 25-foot rock bridge. We were glad to have Paul show up as supervisor in the middle of day! We removed about a 14-inch waist-high blowdown from the existing A.T. **Summary:** I was shuttled to McQueens Gap by Mt Rogers Outfitters (MRO) and worked my way back to Damascus. The trail was snow packed; however, I was able to do a lot of lopping, along with tree removal and cutting back greenbriar from Abingdon Gap Shelter to the State Line. There are two very large pine trees across the trail just south of Damascus; however, Dave Patrick of MRO implied that MRO would take care of them. Abingdon Gap Shelter was in good shape, and the road going up to McQueens Gap was passable with 4WD.

There were plenty of mostly small blowdowns, leaning rhododendron and one bad obstruction, all of which were cleared. One large tree and rootball above the fourth bridge is easy for hikers to bypass.
