A.T. Maintenance Reports

#### From the Chair

Did you know that TEHCC co-sponsors a hiking challenge? South Beyond 6000 (SB6K) is recognition for reaching the summits of the 40 highest and most outstanding peaks in the eastern United States, which are located in North Carolina and Tennessee. The SB6K program is jointly operated with the Carolina Mountain Club. The last TEHCC hikes with the "SB6K" prefix were back in 2009-2010; however, maybe a new group will take interest in tackling this adventure.

<u>Smokies 900 Miler (S900M)</u> is another popular hiking challenge to cover the roughly 900 miles of trails in the Great Smoky Mountains National Park. However, it takes more time and distance (typically

1,500 miles) to get every segment marked on the official park map. During 2003-2009, Kent and Nancy Wilson led many hikes working towards this challenge which was accomplished in 2011; thus they could provide insight on how to reach this goal.

For members of BSA Sequoyah Council, recognition for hiking on the Appalachian Trail, between Allen Gap (TN70 at NC border) up to Damascus, VA town hall, can be received. A central light blue circular patch has seven rocker segments to show progress towards completing the overall challenge. Troop 48 has an information sheet (here). An alternative version of the challenge exists with the distance farther up into Virginia.

## 2013-14 Deer Hunting Seasons

Vic Hasler reporting; update of an article written by Joe DeLoach in 2011

Each fall, hikers are joined in the woods by hunters who are out for small and big game. Deer hunting is popular in our mountains and during firearms seasons can pose more of a risk to hikers than bow hunting or hunting for other prey. Many of our local trails pass through national forests where hunting is permitted. For 2013-14, deer hunting seasons in our area are as follows.

#### East Tennessee (Sunday hunting permitted)

Muzzleloading: November 9 - January 5

Gun: November 23 – January 5 Youth: October 26-27, January 11-12

Western North Carolina, Watauga and Ashe Counties (Sunday hunting with firearms prohibited, archery allowed)

Muzzleloading: November 9-22 Gun: November 23 – January 1

Other Western NC Counties (Sunday hunting with firearms prohibited, archery allowed)

Muzzleloading: September 30 - October 12

Gun: November 25 - December 14

Southwest Virginia (Sunday hunting prohibited)

Muzzleloading: November 2-15 and December 14 - January 4

Gun: November 16 - 30

Hikers should note the prohibitions on Sunday hunting in Virginia and North Carolina. Also worth consideration are national park lands such as the Great Smoky Mountains, Blue Ridge Parkway, and Cumberland Gap; state parks such as Warrior's Path, Roan Mountain, and Breaks Interstate; and city parks such as Bays and Buffalo Mountain. Many of these parks border land where hunting is permitted and the borders aren't always evident; Hampton Creek Cove Natural Area and Buffalo Mountain Park are good examples. Some Virginia state parks, including Grayson Highlands, Natural Tunnel, and Hungry Mother, allow some hunting; hikers wishing to visit those parks in the fall are encouraged to contact the park offices. Hunting is permitted along the Appalachian Trail within national forests and it is lawful to hunt from the Trail itself. During hunting season, hikers are urged to wear blaze orange. Packs often cover a hiker's back, so a cap and orange ribbons tied to the pack in addition to an orange jacket or vest are encouraged. If you bring your dog, it should wear orange too. Hiking groups tend to cause more commotion than a lone hiker and hiking with others is strongly encouraged in areas where hunting is permitted. Be especially careful the first few days of the season.

## Oliver Hollow Road to Wilbur Dam Temporarily Closed

Bear activity has led the Watauga Ranger District to temporarily close portions of the Cherokee National Forest around Watauga Lake from August 22 – December 1, 2013. The Watauga Lake shelter on the Appalachian Trail is closed to camping but the trail is open to through hikers. ## **TEHCC Rental Equipment: REI Kingdom 6 Tent (HT-26)**

After a decade of service, the Eureka! Base Camp Outfitter 6 tents (HT-26 and 27) were retired. One has since been replaced with a REI Kingdom 6 tent purchased from REI (Asheville) for \$528. It's definitely a campground tent, weighing just less than 20 pounds. The hoop design with vertical ends gives a 6′ 3″ peak height to stand up. A central divider creates two rooms of which one can become a screen room when the fly is rolled up or removed. Set-up will take two folks about 10-15 minutes, but is reported to be easier than the Hobitat tents (HT-15 and 21). The club did purchase the fitted footprint to protect the bottom of the tent. Also get at least eight heavy duty stakes to line out the tent in case of wind. For more information, contact Terry Dougherty, Rental Equipment Coordinator.



## **Revenue from Tennessee A.T. License Plate Program**

The Tennessee Appalachian Trail license plate program is paying devidends. Ed Montgomery conceived the idea for this program and Ed's son designed the plate; Ed, Jake Mitchell, and others worked to make it a reality. Since then, there has been year-over-year growth in revenue generated by the license plate. Over \$111,000 has been raised to support the A.T. in Tennessee since the first funds were received in early 2011. As of October 2012, there were 2257 Tennessee A.T. license plates on the road, likely to have surpassed 2500 by now. Along with the North Carolina license plate program, which was established 6 years earlier, almost \$1 million has been raised in the two states. Tennessee license plate funds are used by the Appalchian Trail Conservancy to support projects in Tennessee and to assist with land protection. They are also made available to organizations in the form of grants. This year, TEHCC applied for and received a grant to cover dinner for our Hard Core hiker volunteers after their work on relocating a Trail section on White Rocks Mountain. Funds were also provided to the Southern Appalachian Wilderness Stewards who handle section maintenance in the Big Laurel Branch Wilderness Study Area and helped on the relocation at Turkeypen Gap on Iron Mountain. We thank those who conceived of and worked on the license plate, and those who have purchased it, for their support of the Appalachian Trail in our state.

#### A.T.: Roan High Knob Shelter/Cloudland Trail, Sunday, September 8, 2013

This hike is the replacement for the rain-cancelled section walk scheduled back on August 18<sup>th</sup>. It has also been redesigned to eliminate the shuttle, so that just one car is needed for an easy stroll around former Cloudland hotel area. First, from the parking lot we'll head northbound on the Appalachian Trail to the short side path up to Roan High Knob shelter. At 6,285', it is the highest elevation shelter on the entire A.T. and of unique design being the cabin for a fire warden who patrolled from a former fire tower that was nearby. Then backtracking to the parking lot, we will take the short 1.2 mile Cloudland Trail over to Roan High Bluff overlook for views as shown on the right. Departure time is 1 p.m. from the parking lot below the McDonalds in Colonial Heights. It is an 80-minute drive down thru Elizabethton to reach Carver's Gap. Expected return is between 6-7 p.m. depending on how long we linger to check out the shelter and enjoy the views. A light jacket is recommended as it may be more "fall" like than down in town, and also water to sip.
