### Trail Wiki Update

After another month of furious plumbing work on our trail wiki, we have some new content. My ultimate goal is to make it easier to find trails based on your criteria. I believe we're getting close.

Essentially, information can now be "tagged" on the pages. For example, we can tag that the hike time is 5 hrs. Then hopefully in the future, we can have a search that allows you to find that hike if you're interested in a 4 to 6 hour hike. I've had a lot of internal debates on what to tag before reworking each trail page, but I think I have a good list. Work is now needed to convert each trail page to use the new format. Until that work is complete, you might see some errors on the trail pages.

I've also started Park pages with their own info box on the right. My plan is to better document the amenities of parks to help you plan trips to parks for either weekend camping or a day of fun with family. See Roan Mountain State Park as an example of what I am working towards.

As for content updates, following a 3-day weekend camping trip, there have been significant updates to the Roan Mountain State Park site and its 11 trails. Also based on recent hikes, look for updates to Squibb Creek Falls and Sills Branch Falls.

As always, I welcome others to contribute to the wiki and welcome any other form of assistance. Help can come in any form, anything from detailed site editing to calling me on the phone and telling me to make some changes. If you're interested in helping, please contact me.

### **Trail Wiki Feature of the Month**

I am trying a new segment which may serve a few purposes. Each month I will try to highlight either a park or a trail on our wiki and relay the information we have within. Hopefully you'll learn something that may inspire you to visit. Maybe you'll notice something that I'm missing and offer updates, photos, or descriptions. Or maybe you'll be encouraged to start checking out the wiki and, if I'm really lucky, start contributing and editing. We have a lot of great trails in our area and it's a lot of work to document them all, even with Vic Hasler's help. Currently our site lists 169 trails and growing!

<u>Roan Mountain State Park</u> is a 2,006-acre state park operated by the Tennessee Department of Environment and Conservation that is just over an hour drive from downtown Kingsport. It has 11 official trails with a total of 12.8 miles of hiking. There are no day use fees for hiking.



Onsite amenities include lodging in cabins, RV sites, and tent only campsites including group campsites. The lower RV sites now include Wi-Fi, although on my recent visit I had trouble getting online. I didn't care enough to ask a ranger if I was doing something wrong. Other site amenities include a volleyball court, tennis courts, amphitheater, and apparently the highest elevation of a state park pool in Tennessee (that's a lot of qualifications!). There are also pavilions and a modern conference center available with advance reservations.

Two historical artifacts of interest are the Miller homestead on Strawberry Bald and the Peg Leg Mine. The Miller homestead was built over 100 years ago and was occupied until the 1960's without electricity or running water. While you can visit the homestead any time of year until 5pm when the gates are promptly locked, the house is open for tours Wed-Sun 9am-5pm, Memorial day through Labor Day. The Peg Leg Mine, located just behind the visitors center, mined iron ore, and up until the last few years you could walk down to the mine and go on guided tours.

The trails overall are good. A lot of them stay fairly close to TN 143 making it hard to get away from the road noise. The one exception is <u>Chestnut Ridge Trail</u>. It's a splendid ridge trail, but it suffers the classic problem of trails in Appalachia. You are teased by majestic views that are blocked by tree foliage. A winter trip after the leaves have fallen may fix that problem. The one spot offering a lookout from the trail is <u>Raven Rock Trail</u>.

Throughout the year, the park hosts several events, including naturalist ralleys, folk life and fall harvest festivals at the homestead, and the popular rhododendron festival in late June.

As I have done for years, most people drive through this park on their way to Carvers Gap. If you have the time, stop and look around. You just may find more than you expected and decide the trip up to Carvers Gap can wait until some other time.

#### **Standard Hike Information**

Hikes leaving from "Colonial Heights" gather at the parking lot below McDonalds, 4317 Fort Henry Drive, which is NW of I-81 Exit 59. "Johnson City" meeting location is behind Parkway Discount Wine & Liquor just off I-81 Exit 24 at the intersection of University Parkway and South Roan Street. "Gate City" spot is up on the hill above US 23 at Kane Street intersection (traffic light) by Food Lion. All hikes will leave promptly to stay on schedule. Carpooling is encouraged with passengers providing a few dollars each towards gas.

Bring adequate water, snack/lunch, clothing appropriate for the weather, comfortable footwear, headgear/sun protection, bug spray, camera, and trekking poles as desired. At the discretion of the hike leader, the family dog can come, if friendly, and kept on leash. Walking speed is typically 2 mph including rest breaks. For more information, check the trail wiki (click on hike title if underlined for the link) or call the hike leader. It is appropriate to contact the hike leader to let them know that you are interested in coming and provide a cell phone number in case plans change for either party.

An activity release form is signed by everyone going on the hike – and it helps capture the names and spelling for the trip report. Good digital photos from the hike are also appreciated for the newsletter and trail wiki.

**Summary:** The TEHCC A.T. Committee met to discuss a myriad of topics. No bear encounters have been reported since June. USFS needs to be asked about policy regarding a loose hunting dog on the trail. A hiker called the number on its radio collar to learn the owner was on the other side of Sullivan County. Reuben Potter (USFS) is out west fighting forest fires.

Students receiving Tennessee Promise scholarships need eight hours of community service per term (first due by 8/1/2016). Thus, a partnership could be arranged, such as discussed with a teacher at Daniel Boone High School. "A Walk in the Woods" movie is opening September 2. After the meeting, I found that Carmike 14 in Johnson City and Cinemark Tinseltown USA in Bristol are showing the film.

The relocation and rehab south of TN 91 was successfully completed with ASU Watauga College who would like to continue the partnership. USFS Watauga Ranger District is interested in having the student group work on other trails; TEHCC might need to assist. Similar to Hard Core moving to the MRATC section, TEHCC will want to revisit the club's approach to non-A.T. work.

There's been no word on a TN license plate (LP) grant for shelter repair. If funds are provided in 2015, an extension will be requested for 2016 since only a few purchases could be made this late in the year. With wood handles disappearing on shovels at several shelters, the committee agreed to switch to fiberglass handles at specific places.

The committee discussed the following changes and updates to our capital plans, which will be reviewed with ATC on October 7. Little Rock Knob was done in 2014 and Cross Mountain in 2015 with ASU assistance. Rehab Doll Flats to Hump (2015) has some remaining work right at Hump Mtn. Relocation at Turkey Pen Gap has not yet been opened – short by 20' on both ends (some through poison ivy). Concern expressed that SAWS groups has not performed any maintenance on Section 6, Iron Mountain Shelter to Vandeventer Shelter, in 2015. TEHCC will open this relocation during winter if not completed before that. Six projects at shelters are pending the receipt of TN LP funding. Old Ridge Rd (2016) has been flagged and is being planned for work with ASU. Club resources would handle Deep Gap (2016), Shook Branch Bridge (2016) and Wilder Mine Bridge (2017). Projects with Konnarock Crew are currently on hold until 2018 continuing work on Backbone Rock, 2019 Atwood Property (US 321 crossing), and 2020/2021 South of Greasy Creek Gap. Accessible Trail at Osborne Farm will be a new and wider surface constructed (backhoe) by contractor - does not involve club resources. New items for capital plan would be replacing Cherry Gap Shelter in 2018 and No Business Knob Shelter in 2020. Repairing or replacing Laurel Fork Bridges and relocating steep, eroded trail North of Temple Hill Gap were not assigned a target date or resources at this time.

TEHCC has been assigned Oct 9 - 30 for Trail Asset Inventory with proposal to cover Sections 10-15b (Hampton to Hughes Gap). We'll start with training in Dennis Cove in order to have a variety of features (shelter, bridges, steps, trailhead). The committee has several questions about expectations that will be asked of ATC – and CMC who is the first club in SORO performing this task.

Topics were reviewed for October 7 partnership meeting (Mars Hill) and SORO on October 17.

Division of TEHCC A.T. Project Coordinator duties was discussed after Carl outlined evolution of the current situation. Since his retirement from Eastman in 2001, the position has accumulated duties: tool shed built in 2004, chainsaw, Konnarock, etc. Other factors have been: more people participating weekly (12-16) which means more tools to have ready; hard hats are now required; SORO ATC has grown from two to six staff to have more initiatives, such as A.T. communities, invasives removal, and trail assessment/inventory. The basic need is to unbundle the position to return it to a basic coordinator role. A.T. committee members nominate new members to the committee, which allows for some recognition of a person's commitment and interest prior to becoming involved in committee details. Current distribution list can be modified to invite other interested folks. The committee noted that several pieces can be broken out. Recommendation was to create short job descriptions to inform and recruit those who don't want to "dig dirt" but are willing to help elsewhere. The group talked about storing extra tools needed for large events in B-310 if bins were provided, while other tools could be transferred to others, if TEHCC events will only have 50 folks maximum in the future.

Revisions to the 14th Edition TN-NC ATC Guidebook are now being gathered. Electronic copies of the text file will be distributed for more comments – from point of view of a hiker. Goal is to have first draft by November, final in January 2016 for subsequent publication. Two kiosks have been recently installed at Carvers Gap and Nolichucky Bridge.
