Trail Wiki Update

Last month we started receiving updates from someone in the area; an avid technical hiker, like me, who has been GPS-logging hikes for years. We've already seen several great updates and I look forward to working with this person and others in the future.

For me, the month was spent with my current task of flagging the quality and needs of each page. This will allow me, or others, to retrieve a dynamic list of the specific needs for each trail page. The needs include formatting updates, data updates, GPS logs, pictures, and more. This first step is necessary to identify the pages still lacking the format that enables trail searching. Although I have been able to get a simple version of trail searching working for myself, the trails formatted for it are currently limiting the results.

In December, I hope to start updating the required page formats; thus allowing me to develop a "public" version of trail searching early next year. In the meantime, use the website, hike your hike, and come back and report for the benefit of others!

Trail Wiki Feature of the Month

Tim Schaefer Reporting

Bays Mountain Park is a 3,550-acre city park with 31 trails covering a total of 38.9 miles for hiking and most for mountain biking. There is a \$4 entrance fee, but yearly memberships for individuals (\$25) and family (\$35) are available and provide additional park perks.

Onsite features include a nature center, planetarium, zipline, adventure course, and animal habitats. No lodging or camping is allowed in the park, but it appears that park-organized camping events do occur on occasion. The lake doesn't allow swimming and is open to paddlers only once a month. Many love to come and see the work of the beavers chewing down trees for dams and homes.

There are many historical structures within the park. Many families lived within the park boundaries when the dam was initially created back in the early 1900's and many of their homes, barns, and out buildings remain to this day. I find it interesting to see these homes and imagine how it must have been to survive without our modern day conveniences.

The network of trails allows you to create nearly any hike that you're interested in doing. Short, long, lakeside, hill climbing, overlooks, history exploration, are all available. Most trails are fairly wide and work well for group outings allowing side by side walking and conversations. Just one note of caution: the trails in the south-western portion of the park are not well marked, and in some places, not well defined. Be sure to bring a map with you and a good sense of direction, if you venture into this area.

If it's been a while or if you've never visited Bays Mountain, come see one of Kinsport's finest gems.

Standard Hike Information

Hikes leaving from "Colonial Heights" gather at the parking lot below McDonalds, 4317 Fort Henry Drive, which is NW of I-81 Exit 59. The "Johnson City" meeting location is behind Parkway Discount Wine & Liquor just off I-81 Exit 24 at the intersection of University Parkway and South Roan Street. The "Gate City" spot is up on the hill above US 23 at Kane Street intersection (traffic light) by Food Lion. All hikes will leave promptly to stay on schedule. Carpooling is encouraged with passengers providing a few dollars each towards gas.

Bring adequate water, snack/lunch, clothing appropriate for the weather, comfortable footwear, headgear/sun protection, bug spray, camera, and trekking poles as desired. At the discretion of the hike leader, the family dog can come, if friendly, and kept on leash. Walking speed is typically 2 mph including rest breaks. For more information, check the trail wiki (click on hike title if underlined for the link) or call the hike leader. It is appropriate to contact the hike leader to let them know that you are interested in coming and provide a cell phone number in case plans change for either party.

An activity release form is signed by everyone going on the hike – and it helps capture the names and spelling for the trip report. Good digital photos from the hike are also appreciated for the newsletter and trail wiki.

We met at the Bays Mountain Park dam at 8:30 am for our 11-mile adventure. It wasn't long and we began passing by the structures within the park. We didn't find all of them, but we did see most of them. Having to improvise as we went along, we soon realized that we didn't want to head east on Back Hollow Road. As the trail wiki stated, the trail is a stream and it was flowing on this cold morning. Having already hopped across a soggy grazing pasture and several small streams we turned up Pretty Ridge Trail between the barn and house. This ended up being a difficult navigation as well as the trail was indistinct in parts and lacking some markers. We pushed on up the ridge and eventually found the trail again. The sun was shining and the temperature was just cool enough to make for a comfortable hike without fussing with layers. Bob Miller, Vic Hasler, Patrice Riesenberg, and Carrie, Jamie, Elliott ("Bob"), and Josie Schaefer attended. Bob Miller, the most experienced hiker of the crew, led the way, beginning with a sweet fingerplay he sang for three year-old Josie. He identified several native plants, including Christmas fern (Polystichum acrostichoides), maidenhair fern (Adiantum pedatum), trailing arbutus (Epigaea repens), galax (Galax urceolata), wild ginger (Asarum canadense), Cranefly orchid (Tipularia discolor), and Pipsissewa (Chimaphila umbellata). He also offered to carry young Josie if I tired; I didn't take him up on this offer, but I am considering dragging him with me on all future hikes. Near the end of the hike, we coincidentally united with the TEHCC "Bays Structure Tour" group. We stopped for a combined group photo on a reservoir viewing platform. While dragonflies swarmed us, we



lingered to admire a stealthy praying mantis resting on the sphagnum moss beside the platform.

Summary: Mike Hupko, Jr. hiked from 19E to Dennis Cove and made a detailed report of blowdowns about ten days ago. All of these were cleared this week thanks to many volunteers. Jim and Gerald did the blowdown removal on this section and some brushing, and cleared some water diversions. Tim and Greg walked "uphill" all day and recorded the trail inventory.

Summary: It was an awesome day on the trail. We cut the end off a log used to shore up the bog bridge, as reported to me by yesterday's crew, and used the cut end to help wedge the bridge. We rehabbed two sections: one 35' and the other 15'. We also cleared 7 minor blowdowns, cleaned 16 waterbars, and pulled lots of limbs from small, dead trees across the old trail to discourage ATV riders. From past trips, it seems to be working. We cut back multiflora rose in spots and trimmed where needed. We found the trail to be very clean. We met one flip-flop thru-hiker heading north.

Summary: What started as a hike, turned into a maintenance day as the trail was full of limbs and small blowdowns. I was able to pitch, pull, and saw everything that I saw in the trail. My goal was Little Rock Knob, but I ran out of time and stopped just north of Clyde Smith Shelter. The trail is free of obstructions and in great shape as far as I went. Oh by the way, it was a drop-dead beautiful day.

Summary: We relocated one metal marker post in Beauty Spot Gap and installed three metal and two wooden marker posts in Beauty Spot. Two metal posts had been removed from the trail and left near the Beauty Spot parking area. We relocated one of the old metal posts and installed two new metal posts. One wooden posts is about 300 feet south of the fire ring at the top of Beauty Spot and the other is about 100 feet north of the fire ring. We also removed trash from the campsite area. At home, we had prepared the wooden and metal posts for installation.

Summary: The Thursday Crew had a beautiful day to work at Overmountain Shelter. They cleaned the access road culvert, so it should not plug next spring. They redug the ditch and lengthened it at the trail access to the barn. This should prevent the wetweather springs from inundating the trail during wet weather. They also fastened down the siding on the barn side next to the privy. They cribbed the entire front edge of the open area including the sleeping platforms. Then they backfilled with soil to level the area.

Summary: A large portion of the TEHCC A.T. Committee gathered. First action was to welcome Greg Kramer and Dan Firth officially as new members. The group ranked a list of best-practices training webinars for ATC to pursue in 2016. Our top areas of interest were reaching out to new volunteers through various methods, working with colleges, and hosting local partnership discussions.

The TEHCC Steering Committee has provided roughly \$2300 in 2015 for maintenance and trail signs; thus the A.T. Committee wholeheartedly expressed their appreciation. Approval was given to order more TEHCC maintenance contact cards. Steve Falling reported that the committee has a healthy balance, including a \$4700 license plate grant for shelter and bridge projects in 2016. While interest rates are paltry, agreement was made to move funds into Certificates of Deposits, laddered so money is available at intervals without penalty.

Because of feedback, Local Management Plan policy was discussed regarding improving water sources and herbicide use. For the first topic, the decision was to pursue conversation with USFS rangers. The policy statement will be reworked for the second issue to clarify that the agency partner (TVA or USFS) is handling the herbicide when agreed treatment is needed.

Carl Fritz reported that the eight sections remaining for Trail Assessment Inventory are expected to be completed in the next few weeks.

Rehab north of Doll Flats will be finished in "two more weeks" per the Thursday Crew. The Watauga Lake section reopens December 1st. The Club is to leave USFS signs in place for the agency to remove if and when they desire. The bear pole at the shelter was improved by lowering the ground around the base. About a bear box at Watauga Lake Shelter, the decision was made that the USFS needs to be consulted first. We have concerns about a bear box being used as a trash receptacle, thus requiring constant attention. Since the Osborne Farm property now provides an excellent view towards Shady Valley, an outcome for the Berry Fields might be to just maintain a small open view.

NEPA reviews are active for both Shook Branch Bridge and Old Road Ridge relocation with comments due by 11/30. Continuation of Backbone Rock Trail work by Konnarock Crew is expected for a couple more years. Steve Perri suggested proposing a 2020 project for Konnarock by the early 2016 RPC meeting. Until problems with cattle control and fencing at the Osborne Farm site are resolved, work on a new and wider surface for the accessible trail will be delayed.

A 2016 license plate grant application has been filed for hiker maintenance recognition patches. The topic then shifted to the trailangel cooler chained to a tree north of US 19E. Since the organization has been contacted multiple times, agreement was to remove the cooler which Kevin Sedgwick accomplished the following day (see 11/24/2015 report below).

Further progress on the TN-NC ATC guidebook is not expected until Dec-Jan. The Committee decided to remove reference to the spring at Carvers Gap parking lot which is right next to the pit bathroom, but include the blue-blaze spring just trail south of US 143. Steve Perri asked about signs. The group agreed to move the southbound water warning sign for Roan High Knob Shelter to the blue-blaze trail, and to not have a sign at Hughes Gap northbound mentioning the Cloudland day-use area.

We debated storage of extra maintenance tools needed only for large events in the B-310 basement. Fiber drums were suggested instead of heavy-duty polymer pellet boxes. The challenge is moving tools from the B-310 basement. One idea was to issue each regular maintainer their own set of tools to bring; however, transporting them in small vehicles during carpooling was a concern. Conversation shifted to acquiring a tool trailer and maybe staging it at a USFS work site. The main underlying question is what tools should be kept and sustained in good condition over the long-term.
