Roan Naturalist Observations

Created by Vic Hasler based on Travis's weekly reports

For the past several years, a partnership of ATC, SAHC, TEHCC, and USFS has placed a Roan Naturalist in the field to monitor the area and mitigate, as possible, the impact of the heavy public usage through personal encounters with the highland visitors. This year, Travis Bordley has this role, thus this article is sharing a few observations from his six weekend reports so far.

- The Gray's Lilies are having a great year with plenty of big healthy blooms along the Appalachian Trail; however, there is a fungus (lily leaf spot disease) that is causing some flowers to never bloom or prematurely wither. Transmission of the fungus may be caused in part by physical contact by humans. Thus educational signs have been recently posted along the A.T. to raise awareness about the Gray's Lily and to try to slow spread of the disease.
- Peak Saturday visitation to Carver's Gap can exceed 2,000 people. Weekdays (except Friday) can afford a more desirable experience with fewer crowds.
- Foot traffic during the wet weather in May severely impacted the A.T. between Grassy Ridge and Overmountain Shelter. Hikers were observed to be muddy from slipping and sliding down the mountain. In addition, since the A.T. was an absolute swamp, many had diverted onto the shoulder of the path causing further damage. Physical mitigation may be required in several areas to prevent rapid impact during inclement weather.
- A staggering number of social trails up Jane Bald and Grassy Ridge and spur trails by photographers have been created. The partnership needs suitable ideas on how to address this concern with implementation this year or next.

Rating: Easy 2.5 mile walk around the lake at night on Lakeside and Holly Trails

TEHCC has been co-sponsoring the Kingsport FunFest Moonlight Hike at Bays Mountain Park since before 1993. Over the years, this popular event has attracted larger and larger crowds. Parking space is tight at the visitors' center; therefore, to control the number of vehicles, the Moonlight Hike is a ticketed event. However, TEHCC volunteers helping with the event are not required to have an

entrance ticket. To minimize the number of TEHCC cars, if you have fewer than four people, let's gather at the Eastman Lodge back parking lot at 7 pm to carpool. Otherwise, be at the back side of the visitor center facing the lake by 7:30 pm for badges with contact information and to discuss any additional items relevant to the hike. The hike itself kicks off at 8 pm from the dam near the visitors' center. Bring your own flashlight/headlamp (and spare batteries), water, insect repellant, and charged cell phone. TEHCC volunteers will start the hike at the front of the walkers, and then be assigned specific intersections to direct traffic along the right path. Summary: Laurel Fork Creek was roaring today. We trimmed weeds adjacent to the trailhead and under the powerline. We also cut back rhodendron and dog-hobble (and other brush) and removed some branches and small trees from the trail. We maneuvered the rocks at the cribbed area between the creek and rock wall to allow water backed up on the trail to go under the crib log into the creek. We also removed one large bag of trash.

Summary: We cleared brush and small trees from the trail and removed vegetation via trimming. At the large red oak rootball at the spring on top of Pond Mountain we found a huge amount of water flowing around and beneath the rootball. There was a continuous area of water approximately 50-60 feet. We moved rocks into the pool above the rootball, opened drainage under the rootball, and cribbed trail-south of the rootball with additional rocks. The section that lies trail-north of the rootball is very large and sloppy and will likely need many rocks to make it reasonably dry and walkable. We met several thru-hikers and section hikers.

Summary: As a continuation of the trip to North Pond Mountain, we came down the south side and trimmed vegetation (with more left to be done), removed occasional brush and limbs from the trail, removed one log from the trail near the bottom, and worked to divert a "gushing" spring over the trail rather than into the trail near the bottom. Also, approximately two-thirds of the way down the mountain, we noted and photographed a blowdown where the rootball sits immediately below the trail creating a "dip" in the trail that needs repair. Summary: Conflicts, ailments, and storms kept me off the Grassy Ridge Trail until later in the year than usual, with plenty of work to do as a result. There were two unusual occurrences - a blowdown that needed to be sawed out, and a fire ring in the first third of the trail starting from the A.T. I scattered the rocks for the fire ring and brushed out the burned area. I straightened and rebraced the signpost at the Grassy Ridge Trail junction with the A.T.; but this did not prevent two parties on Grassy Ridge from asking me where they took a wrong turn. Volunteer paths are proliferating on Round and Jane Balds. The worst are along the former A.T. route on the Trail south (front) side of Round Bald, and one that parallels the A.T. on Jane Bald.

Summary: The SAWS Naval Academy Crew worked in the Big Laurel Branch Wilderness for seven days from June 6th to June 12th, 2018. The primary focus of this project was to re-route a one-half mile section of the Appalachian Trail in the Turkey Pen Gap area. The trail was relocated to move it away from the fall-line where the old trail is being eroded. The crew consists of two paid crew leaders as well as five volunteers. All seven members of the crew dug the trail using pick-mattocks, pulaskis, and McLeods. The trail was blazed along the way to indicate the new location of the Trail. Our second priority was to brush vegetation trail-south of Turkey Pen Gap.

Purpose: Clear blowdowns

Location: Section 15b, Between Hughes Gap and Ash Gap

Summary: We hiked in from Hughes Gap to the knoll above Ash Gap. South-bound hikers stated there were no blowdowns from the knoll to Cloudland. We cleared five blow downs 8-12" diameter and 11 smaller ones on the hike back to Hughes Gap. We noted that there are numerous dead snags in close proximity to the trail that will probably cause future blowdowns across trail. It might be

worthwhile to make a preemptive strike and fell some of these away from the trail. The weeds on this section are just about at the point where they need to be cut. Several spots were getting pretty weedy. Two areas about a mile and a half from Hughes Gap could use a little side-hill work. The Trail blazes looked good. We encountered some north-bound hikers at Hughes Gap that stated there was a large blowdown about one mile trail-south from Hughes Gap. Thanks to Ed Brooks for being my chainsaw Sherpa and swamper.

Summary: We hiked trail-south from Dennis Cove for about a mile to a reported blowdown. The Trail was pretty well blocked and it appeared hikers had been climbing up a steep bank to bypass it. The blowdown involved a couple of trees and we sawed it out with a chainsaw. On the way back down we painted blazes, removed some smaller obstacles, and cut encroaching vegetation. With all the rain, obviously the weeds are doing very well. We encountered a half-dozen or so hikers and all expressed appreciation for our work.

Summary: I cut weeds and multi-flora roses from US 321 at Shook Branch to the forest service gate. This section has been closed due to high lake level. In spite of a few muddy spots, it is now ready to be opened up. For future reference, we need to watch for Watauga Lake levels above the 1961-foot level to put up the re-route signs.

My goal was to finally remove the mountain laurel and rhododendron growing on the uphill side of the long switchback so that the hikers will walk less on the lower edge of the trail. It required a solid two hours of swing blade, loppers, and handsaw for the full haircut. However, beforehand I had spent an additional three hours working on the mile in the bottomlands cutting stinging nettle, dog hobble, and some rhododendron to keep the path at desired standards. The final hour was lunch and walk back to the access point. The trail was very busy with many folks NOBO, but also a pair SOBO from Nantahala Hiking Club who reported conditions in Virginia were very muddy because of the tropical storm a couple weeks ago.

Summary: I hiked up to Turkey Pen Gap to check on the progress of the SAWS Virginia Naval Acadamy crew working on the second phase of the relo. I am happy to report that it is completed and open for business. The crew did an exceptional job in finishing the project and the new trail looks great. Once we get the project report, Eric or myself will fill out a maintenance form for the work completed.

All springs were flowing pretty well between TN 91 and Turkey Pen Gap. I checked Iron Mountain Shelter; it is clean and was filled with hikers by 5:30 pm.
