Scheduled Events

Suwannee River Multi-Day Paddle Trip, April 17 – 21, 2019

We will paddle the most beautiful and fun section of the river. There are many springs along the way and historic sites to explore, including a sunken ship. There are also swimming holes and places to snorkel, so bring your dive mask!

April 17 is a travel day. For the first night, we will camp at Spirit of the Suwannee Music Park, 3076 95th Dr, Live Oak, FL.

April 18: The next morning at 9 am we will meet at Dowling Park Boat Ramp to load boats, set shuttle, then launch. We'll paddle 9.7 miles to Lafayette Blue Springs State Park (river mile 103.3) and spend the night there. Somewhat primitive camping is available here with plenty of trees and walk-in sites, but there are hand carts to get our gear to the sites. There are bathrooms but no showers.

<u>April 19</u> we'll paddle 8.3 miles to <u>Peacock Slough River Camp</u> (river mile 95.8). We will be stopping at the Suwannee River Rendezvous along the river to eat lunch at a short order grill. They have ice cream!

April 20 we'll paddle 9.7 miles to Adams Tract River Camp (river mile 85.5), which has the same amenities as Peacock Slough.

April 21 we'll paddle 9.3 miles to the take-out in Branford at Ivey Memorial Park, 614 Ivey Memorial Park Dr, Branford, FL.

It's sunny Florida; bring sunscreen. Also a large brimmed hat is helpful. There are poisonous snakes, so watch where you step when you're close to shore and use your light at night when walking around. Cockpit covers are suggested to keep critters out of your boat overnight and bring bug spray. Have at least one bow or stern line on your boat. Invasive Plants Removal, Devils Creek Gap, Saturday, April 27, 2019, 8:30 am – 2:00 pm

TEHCC has been working in this location for the past four years to eradicate invasive plants which were imported to the U.S. but can out-compete native species. The first focus was on Garlic Mustard, imported to be a salad green, that readily spreads as the seeds attach to clothes and animal fur, and thus are dropped in new locations. The plants are easily pulled; however, the seed bed requires multiple annual treatments to exhaust. We'll remove any new plants that have emerged or were overlooked. The second objective, started last year, is chemical treatment of Autumn or Russian Olive, which is a large shrub imported to provide food and cover for birds. However, it crowds out native foliage. We will be cutting Autumn Olive and painting their stems with herbicide to keep the plants from growing back from their roots. Let's leave from Colonial Heights at 8:30 am to arrive at Devils Creek Gap by 9:30 am. Current plans are to work until 1 pm. Matt Drury is scouting out other nearby sites if we are quickly successful in knocking out both of these tasks in Devils Creek Gap. In case of inclement weather, a back-up date of Tuesday, April 30th has been selected.

Doe River Cleanup, Saturday, May 11, 2019, 9:00 am

With summer right around the corner, and everyone starting to get out and play, we are having a massive Doe River Cleanup. Appalachian Paddling Enthusiasts (APEs), Overmountain Chapter Trout Unlimited, and NeTREP's AmeriCorps member, Erica, have partnered to bring you a fun cleanup day along the Doe on Saturday, May 11th from 9-12 pm. The cleanup will focus on two different areas of the River, the Upper Doe and the Lower Doe, to give everyone a chance to join in on the event. Overmountain Trout Unlimited will lead volunteers along the Doe River Fishing Trail (DRiFT) section of the Upper Doe (Happy Trails Parking area to Bear Cage Rd). Volunteers should meet at **Roan Mountain Community Park** at 9 am to determine placement. APEs will lead volunteers along the Lower Doe section (Green Bridge Landing to the Covered Bridge). Volunteers should meet at **Green Bridge Landing** at 9 am to determine placement. Both locations will have trash bags and gloves on site for volunteers, but feel free to bring your own gloves if you would like. Also, be sure to bring plenty of water and wear appropriate clothing (long pants, sturdy shoes). At 12 pm after the cleanup, we invite our volunteers to meet us back at Roan Mountain Community Park for a wood-fired pizza lunch to thank you for your hard work! Summary: We worked a half-day Sunday (due to time constraints we both had) to begin re-blazing the section. We got roughly a third done because we decided to remove the large log over the trail near a wash-through about a mile in from Indian Grave Gap. The downhill edge of the trail at the site of this log is extremely soft and was easily loosened from our activity; therefore we cribbed about 7 feet of the edge to shore it up a bit. As someone (Scouts?) recently cut more of the rhodo back on my section, the main thing left to do is finish re-blazing and remove the old junk below the wash-through, which will be done in the next week or so. Hikers reported blowdowns on 19b, but didn't remember exactly where.

Summary: The trip was an in-and-out to check the shelter and condition of the trail to determine what maintenance needed to be done. I left 13 blowdowns as step-overs; all other limbs and brush were removed. The shelter is in good shape, but I'm worried about a tree south of the shelter; the top was blown out and it looks worse for wear. It's not a hazard tree, but needs to be dealt with in a year or so. I located the weedy areas along the trail. The trail overall was in great shape. The waterbars need cleaning; but with all the recent rains, only one area had water on the trail.

Summary: We cut back rhodos from Bitter End to Hardcore Cascades. We cleared about 17 blowdowns of 6" to 15". Richard as sawyer and Tony as swamper got to about a mile S of Moreland Gap Shelter. We rehabbed three minor sloughing sections by redigging trail and reinstalled a sign at Hardcore Cascades. And most importantly we were able to reposition, with rock bars and rope pulley hoist, one of the key stepping stones which had become unstable. We reinforced it and several other steps with additional rocks. The cascades were beautiful and the water was cold.

Eventually, they took up with some hikers headed north. The huskee eventually caught up with Tim, Dean, and Carl who had gone in at Moreland Gap Shelter and headed north to Canute Place. So the huskee hiked in seven miles and then followed the truck another seven miles back to Bitter End. He had enough and eased home for a food bowl and bed.

Summary: Vic and I attended the Southern Partnership Committee (RPC) Meeting held each spring bringing together the clubs from the Virginia Region and Southern Region along with ATC, Appalachian NP, and the USFS representatives from GA through VA. Significant policies are reviewed and approved in this forum along with communication of events and issues that affect the work groups. At this meeting, a new A.T. experience management system of zones was presented along with a recent RPC survey of the effectiveness of the meeting format, and ATC's restructuring of one of the regions as a pilot study. Clubs provided input for the new strategic plan which will cover 2019-2021. TEHCC requested 2 weeks of Konnarock crew time for 2024, which was approved by the committee. Clubs are still working on completing and getting approval of their Local Management Plans, MOUs, and Volunteer Service Agreements. TEHCC has completed all of these except the Local Management Plan for which we are currently seeking ATC and USFS signatures. This was Steve's last meeting as Chair of the Committee with a new chair taking over at the annual membership meeting in September.

Summary: The first 3rd-Saturday trip of 2019 was a great success. Four hardy volunteers showed up on a very cold morning to work on the A.T. The main task was to clean water diversions between Iron Mtn Gap and Weedy Gap. There were 31 of them in this two-mile stretch! Lori, Randy and Kim worked diligently to clean out the debris that had accumulated over the winter so that they can function to protect the treadway. Phyllis and Kelly hiked out to Greasy Creak Gap and back, scouting for blowdowns. Surprisingly, they only found two, both within a mile and a half of Greasy Creek Gap. One was a large dead tree which is easily walked around and the other was mostly the top of a tree. They cleared smaller limbs from the latter one and it is now also easily walked around. We also removed the flagging from the first three, now abandoned, relocations on this section.

Although we had plenty of sunshine all day, the temperature remained low and the wind was quite cold and unpleasant up on the ridge.
