Southern Appalachian Highlands Conservancy Recognizes Maintainers

At this year's Appalachian Spring Conservation Celebration on Thursday, May 16th, SAHC will recognize the Tennessee Eastman Hiking and Canoeing Club with their 2019 Stanley A. Murray Award for Volunteer Service. This honor was created for outstanding volunteer contributions to the work of SAHC emulating the lifelong dedication of their founder, Stanley A. Murray... who also was an excellent leader for the ATC and TEHCC.

"This year, we honor the Tennessee Eastman Hiking and Canoeing Club for its extraordinary volunteer help in 2018, managing Golden-winged Warbler habitat," said Marquette Crockett, SAHC's Roan Stewardship Director. "TEHCC members made numerous trips to open up 2.5 acres of new habitat for Golden-winged Warblers. They donated fuel, equipment, and more than 383 hours cutting locusts, then spent another 403 hours de-barking and transporting the locust to be used in repairing sections of the Appalachian Trail across the Roan Highlands. In addition, several members of the club participated in trail planning and building on SAHC's Elk Hollow preserve. We appreciate their commitment and dedication to the Roan."

Doe River Cleanup, Saturday, May 11, 2019, 9:00 am

With summer right around the corner, and everyone starting to get out and play, we are having a massive Doe River Cleanup. Appalachian Paddling Enthusiasts (APEs), Overmountain Chapter Trout Unlimited, and NeTREP's AmeriCorps member, Erica, have partnered to bring you a fun cleanup day along the Doe on Saturday, May 11th from 9-12 pm. The cleanup will focus on two

different areas of the River, the Upper Doe and the Lower Doe, to give everyone a chance to join in on the event. Overmountain Trout Unlimited will lead volunteers along the Doe River Fishing Trail (DRiFT) section of the Upper Doe (Happy Trails Parking area to Bear Cage Rd). Volunteers should meet at **Roan Mountain Community Park** at 9 am to determine placement. APEs will lead volunteers along the Lower Doe section (Green Bridge Landing to the Covered Bridge). Volunteers should meet at **Green Bridge Landing** at 9 am to determine placement. They say that the third time's a charm. We have had two aborted attempts at painting Curly Maple Gap shelter, once due to a hurricane and once due to the government shutdown. So this month it is time for the third try. Curly Maple Gap shelter was rebuilt in 2010 and as such is one of our newer shelters. However, over the years, it has collected an abundance of graffiti which is quite unsightly. So the goal for this month's trip will be to paint the interior of the shelter and cover up all the graffiti.

For those folks who may not wish to climb around inside a shelter and get paint on themselves, there will also be an opportunity to do actual trail work. There are a few places between Indian Grave Gap and the shelter that need some rehabbing and we hope to address that also.

All materials and tools will be provided. Volunteers need to bring food and water sufficient for the day and wear weather appropriate clothing (if you are painting, you might consider paint friendly clothing). Work gloves are also recommended as well as long pants and sturdy walking shoes.

Hootennany Hang and Paddle Weekend, June 7 – 9, 2019

The Hootenanny Hang Weekend will be at Blackberry Blossom Farm and Campground, 250 Blackberry Blossom Ln in Unicoi, Roan Mountain area, 20 minutes from the Nolichucky River and Watauga Lake. Now a Hootenanny means "Music Happening!" So there will be picking on the porch by the Mitten Family Pickers and anyone with an instrument can join in! On Saturday night we'll have a pot luck dinner and a raffle of hammock camping gear to help pay for the use of the campground. Any money left over will go toward a deposit for next year or be donated to the farm for any needed projects. There are 98 acres of wooded property at Blackberry Blossom Farm with walk-in-only camp sites. Backpackers will be right at home; but if you have heavy gear, they will gladly haul it to your site with their tractor and small trailer. The sites have fire pits, picnic tables and potable water. There are two bathrooms with showers and a large outside sink for clean-up near the camp store.

Activities: We're planning paddle trips and hikes for Saturday morning. You can choose between two kinds of kayaking, whitewater (Nolichucky Gorge Class III-IV or Lower Nolichucky River Class I-II) or lake (Watauga Lake with a picnic on the Island). There will be led hiking trips too. Hike Roan Mountain to the balds from Carvers Gap or drive up to the Rhododendron Gardens. The pot luck will be Saturday Night after the activities at the Camp Store. There is a communal fire-pit where dutch oven cooking will be done. Tickets to the gear raffle will be sold and paid for Saturday night at the event. Bring cash to buy your tickets: \$5 per ticket or 5 for \$20. I am gathering raffle donations from hammock camping vendors, but your donations are accepted too. Any spare gear you have will help; it doesn't have to be a lot, just something camping related someone can use.

Camping Cost: We have come to a flat-rate agreement for the cost of the campground. I am asking each person who attends to please give a donation or buy raffle tickets. Your donations and the raffle should cover the cost of the venue and any other expenditures like firewood, deposit for next year etc.

A.T. Maintenance Reports

Reporting: Lynn DiFiore **Date:** 3/23/2019

Purpose: Routine Maintenance

Location: Section 14b, Stan Murray Shelter to Overmountain Shelter

People: Lynn DiFiore, Eilidh (canine)

Summary: I spent a good day clearing out winter blowdowns and picking up a minor amount of trash from both shelters. Eilidh with her trusty pack hauled out all the trash from Stan Murray! I used a handsaw to clear a large number of blowdowns, mostly limbs. One larger tree is down that will need a chainsaw, but it is easily stepped over and the hikers are not bypassing it. The trail was very muddy and slick from recent snows. That was the only complaint I heard from most hikers. The barn was completely full with many tents in the field. One group was building a blazing bonfire in the field. I attempted to pass along some LNT guidance, but they were too worried about being cold to pay much attention. Otherwise, a good day to be out!

Summary: Bob Killian, a hiker, made an extra effort to come out on a maintenance trip. His conclusion is that the maintenance day will be his toughest day on the trail.

We removed a dozen chainsaw blowdowns plus some smaller ones, cleared all water diversions and added some more, and stabilized some steps. The trail is in good shape. Much additional work is needed on the approach to Hump Mountain with its rich organic soil and heavy rainfall. The water trail at Doll Flats needs to be blue blazed and a couple of water signs. We saw a dozen hikers today.

Purpose: Routine Maintenance

Location: Section 14b, Overmountain Shelter to Bradley Gap

Summary: We cleared numerous blowdowns from the barn to Bradley Gap and picked up a moderate amount of trash at the Bradley Gap campsites. The ever recurring firering at the rocks on Little Hump has become huge; the hikers are expending alot of effort to haul up very large boulders. The campsite seems to be very well established at this point. There is evidence of a vehicle traveling up towards Yellow Mtn on the road from Roaring Creek, but it did not access the balds. I removed a firering that was constructed inside the barn and picked up a minor amount of trash at the barn. The shelter was full, again with numerous tents in the field. The majority seemed to be thru hikers. Spring beauties and ramps are starting to show, which seems early to me!

Purpose: Clear reported blowdowns and assess extent of garlic mustard infestation

Location: Section 19b, Nolichucky River Outfitter to switchback, Chestoa parking lot to recreation area

Summary: Mary Ellen and Rick Virost sent an email on 3/17 with photos of six small blowdowns in the Jones Branch area. Someone else had already opened five (thanks to whoever you are), so my morning effort was clearing an 8" hurdle, tossing blowdown pieces further into the forest, and some lopping. After lunch, I investigated the invasive species report for garlic mustard made by John Odell (former ATC) in May 2014 citing an infestation beside the A.T. near the CSX railroad. Just six plants were found at the coordinates, so instead, I picked up trash along Jones Branch Road... and discovered more garlic mustard on both sides. I continued to remove trash, mostly large glass bottles scattered around the former homeless campsite. This extensive effort created a pile at

the Chestoa recreation restrooms of garbage and grocery bags, along with a tent, tarp, and sleeping bag. Three grocery bags of aluminum cans were taken to the scouts for recycle. The final count was around 75 garlic mustard plants pulled from across the few acres.

Purpose: Cut and remove winter blowdowns

Location: Section 15a, Cloudland Hotel to Carvers Gap

Summary: We hiked up the road from Carver's Gap to the Cloudland Hotel site, then came down the A.T. to Carver's Gap. We removed five blowdowns that could be removed with a handsaw. We checked the shelter and removed only one plastic water bottle! Fifty-five people have stayed in the shelter since we were there in February. Progress was very slow due to ice on the trail.

Purpose: Spring 2019 A.T. Partnership Meeting **Location:** Watauga Ranger Station, Unicoi, TN

Summary: The partners engaged in very active conversation. This summary has a few topics to share with the general club.

- Initial A.T. relocation from Shook Branch Road to Pond Mtn Wilderness using existing forest roads can proceed after gates are installed to block the lower end of the TVA powerline access road and from Shook Branch Road. TVA and USFS will see what existing gates are available. The local power company will be contacted about removing the line to the former trailer site. "No Camping" signs will be posted at the cemetery.
- Decision was made to move ahead with asbestos abatement for buildings on the Atwood property.
- Approval granted to take Watauga Lake Shelter to the ground.
- Sections of the expansive camping area around Roan High Knob Shelter will be roped off with signage to begin rehab.
- Next partnership meeting to be in October at the Watauga Ranger Station (Unicoi, TN).

Date: 4/3/2019

Purpose: Make and place new poles with trail blaze

Location: Section 12d, Campbell Hollow Road to US 19E, northern end

Summary: Since taking over this section, the poles with blazes in the open grassy areas have been slowly disappearing for one reason or another. Using weather-resistant material, I made a half-dozen poles. I carried them in and placed a few on the northern end of the section. As always, I continued to cut back rose. I hope to get ahead of it before it starts growing. I met 10 thru-hikers, 3 slack packers, and a group from Old Timers Hiking Club from Johnson City. It looks like ATV activity on the trail has started back up.

Purpose: General trail and shelter maintenance

Location: Section 7, Vandeventer Shelter to Wilbur Dam Rd

Summary: I hiked in for an overnight trip to do maintenance between the shelters. During my hike in, I cut out a 24" dead oak, an 18" birch, 2 tree tops and a couple smaller blowdowns. I spent the night at Vandeventer Shelter where there were 4 NOBOs and 2 section hikers staying the night with another group of 4 section hikers staying at the site on the spring trail. The shelter was clean and there was no grafitti even with the grafitti board missing. Both springs on the section are flowing really well; lots of water.

Purpose: General maintenance

Location: Section 6, One mile trail North of Vandeventer Shelter

Summary: On day two of my trip, I cut out a 26" white oak and a 10" locust. I also cut back rhododendron, green briar, and black berry within one mile north of Vandenventer shelter. On the way out, I found a food bag that someone had left at the shelter, which I carried out. On this day, I encountered 18 NOBOs.

Date: 4/4/2019

Purpose: Check section

Location: Section 14c, Stan Murray Shelter to Carvers Gap

People: Richard Carter

Summary: I walked the section, checked the shelter, left a new shelter register, picked up an armload of trash including 4 discarded tarpaulins, checked the spring (which is running well), scattered a firering, lifted 5 or 6 blowdowns of 3-5 inch diameter, and cut 5 blowdowns of 5-6 inch diameter. There is a blowdown of about 26 inches located just south of Stan Murrray Shelter that will need chainsaw removal. I met about 15 NOBO thru-hikers and several day hikers.

Purpose: Scout Trail

Location: Section 20a, Nolichucky River to Temple Hill Gap, first 3 miles from river

Summary: Hikers are coming. We encountered at least 15 in this short time. Craig is doing a great job of cutting growth, digging sloughing trail, installing water diversions, and blazing. We inspected four short, steep bumps between 2 and 3 miles from the river since they were mentioned as possible relocations in the Optimal Location Review in the early 90's. None of these steep sections are eroding. Two of them were up to 35% grades. We thought three of the grades could use a few rock steps to improve hiker traction. We should probably dig some larger water diversions to ensure no erosion in the south-most grade. We could see little value in doing relocations.

Purpose: A.T. Spring Maintenance **Location:** Section 3b, Spring to US 421 **People:** Kelmara Kelly, Steve Perri

Summary: We hiked from TN 421 to the Spring. We removed a few small trees crossing the trail, cut back a lot of briers and rhodos, and painted the blazes in both directions. We left two step-over blowdowns. The first has been there awhile and has no bark left on it about 0.5 mile south of the rock wall. The other we dropped to a safer position as a step over which is visible from the rock wall walking north. We saw 6 thru-hikers and one section hiker. Otherwise section is in good shape.

Summary: Today's main purpose was to get the graffiti board repainted and touch-up places on the walls. A persistent mouse and 3 thru-hikers kept us company while we were working. On the way back, we met countless thru-hikers, including a family from CA with 4 young daughters, the youngest age 5. The prescribed burn between McQueen's Gap and the shelter had been accomplished, and the trail was in good shape.

Purpose: Control camping area at shelter **Location:** Section 15a, Roan High Knob Shelter

Keith Kelley, Chad Ingle, Dennis Trentham, and his two helpers

Summary: The Forest Service removed several broken tree leaners along the trail and near the shelter. Our primary objective, with Chris's leadership, was to restrict the ever expanding camping area beyond the shelter. We strung yellow string with orange flagging and signs to mark much of the area as closed for revegetation because of the imperiled ecosystem. Therefore, no camping, cutting, or gathering firewood. An additional explanatory sign will be posted at the shelter. We will probably have approval to rehab the water trail this summer.

between US 321 centerline and the Pond Mtn Wilderness sign. Per the A.T. guidebook, the current trek on switchbacks is 0.5 mile, which was verified at 2,655 feet. The new path on gravel, then dirt USFS roads, measured as 2,835 feet; so just 180 feet more. No change will be needed to A.T. data or guide books when this partial relocation is implemented. That is, unless the club wants to drop reference to the temporary campsite to see where the thru-hikers will tent, as two more open spots are available.

My second impromptu task was to pull garlic mustard (invasive species) from roughly 300' along Shook Branch Road. Just over 500 plants were removed weighing 17 pounds total.

Summary: The purpose of this trip segment was to locate the unmarked 0.2-mile sidetrail to Potato Top to check its condition. It is listed on the club maintenance assignments and in the A.T. guidebook. I went in from the Dennis Cove Road trailhead with a 0.9-mile hike just past Koonford Bridge. The steep uphill scramble appears to begin right at the old railroad cut. No "trail" was found and there were with few signs of anyone proceeding more than a hundred feet. After bushwhacking up and along the ridge for a quarter mile, the views into Laurel Gorge were mostly obstructed by trees – both evergreen and hardwood. My recommendation is that the club drop references to this side trail as it represents an undesired risk for public users of the wilderness area. No action is required in the field, as there is no sign or blazes to indicate such a route exists.

My last action was to pick up remnants of plastic Easter eggs from the Dennis Cove parking lot, likely holiday trail magic which became litter. It was a cloudy, cool Easter afternoon; however, the weekend rain stopped, so I was able to get outside as did many other families.
