Hiking Program to Start in July

Eastman Chemical has started the process of reintegrating employees working from home back into full-time presence on site, which was one condition set by the club's Steering Committee before the 2020 Hiking Program could begin. While there are a few new cases of COVID-19 infection each day in our region, it is understood that the risk of virus transmission in dispersed outdoor settings is very low. Therefore, the decision has been made to start leading hikes in July with several conditions on the participants. First and foremost, do not come to any hike or event if you are showing any signs of illness, have had contact with anyone with COVID, or have any concerns with your own risk factors. A change from previous years is that the hike leader will not organize carpooling to events. Instead, we plan to meet at the trailhead parking areas (hike leaders are willing to give detailed directions if contacted). Bring your own sanitizing supplies and PPE for preventing virus transmission (masks are not required but encouraged to have available). Also, bring your own drinking water and snacks for the hikes. Conversations will be held with at least 6-foot separation and social distancing will be encouraged during the hike.

Enough of the heavy news; the 2020 Hiking Program hopes to take advantage of the many great hiking opportunities in our area, with outings on most weekends through October. The hikes will vary in length, difficulty, and scenery. The club website tehcc.org will be kept up-to-date with the schedule and latest information on trips.

Trail Maintenance - COVID-19 Phase 2 Adaptive Recovery

Our communities and region are taking a phased approach to reopening activities during the still-active COVID-19 pandemic. North Carolina and Tennessee plus the Appalachian Trail Conservancy have all entered Phase 2 of their respective plans. And fortunately, there are very few active COVID-19 infections in the seven-county area of Northeast Tennessee.

In last month's newsletter, it was announced that the temporary suspension of our Volunteer Service Agreement with the US Forest Service, Pisgah and Cherokee National Forests, had been lifted. It has been great to see the maintenance reports begin flowing again as this club ensures an open path for the Appalachian Trail while we all strive to work safely.

There are several conditions for our operation:

- Most important is that each volunteer must continue to judge whether they feel safe in participating in an outing because of
 potential exposure to COVID-19. Likewise, every volunteer must evaluate their symptoms (coughing, fever, temperature,
 exposure to people having COVID-19, etc.). If you have any concerns, it is critical that you not participate at this time.
- For TEHCC, our maximum group size is now 3-4 under Phase 2. When Phase 3 is implemented in the future, the crew-size limit is expected to roll back to normal.
- Still no carpooling only travel with immediate family (those sheltering together).
- No sharing tools. Maintainers are welcome and encouraged to use their own tools that are in good condition. Otherwise, Carl Fritz has tools owned by the club that can be loaned out during this time.
- Wash hands or use sanitizer frequently, especially before eating.
- Maintain 6' social distancing. If hiker traffic becomes too great, you need to abandon the work in that area.
- Shelters and privies remain closed, so no maintenance on shelters including trash pick-up in their vicinity.
- Reinforce the safety JHA for working under Phase 2 conditions and conduct pre-planning checks as well as reinforce activities in a bumper safety-training discussion in the field.

A new expectation by the Appalachian Trail Conservancy is that maintainers will view the training video and COVID-JHA found on this webpage (appalachiantrail.org/get-involved/volunteer/safety/covid-19) regarding "Volunteer Protocols During COVID-19" and complete the online Acknowledgement form.

Because of the no carpooling condition and having some vulnerable members, our formal Thursday maintenance crews and "Third-Saturday Hiking with Tools" are still suspended for July. Inform Carl Fritz about blowdowns for the club sawyers to address. Also, he and Kim Peters can identify projects for small crews of two to four maintainers. New volunteers are welcome to be paired with section maintainers and these small projects.

Where Can We Go Canoeing and Kayaking?

- Most launch points are open in Tennessee, but nearby facilities may be closed.
- USFS has reopened the Poplar (Nolichucky River) and StackHouse (French Broad River) access points.
- Roll practice at Johnson City and Kingsport Aquatic centers remains cancelled, while these facilities focus on lap swimming.
- USA Raft (Erwin, TN) is not mixing groups, with a maximum of 4-5 per boat (plus guide). At least four people are required for trips on the Nolichucky Gorge and French Broad and two people for Lower Nolichucky.
- The Appalachian Paddling Enthusiasts (APEs) group (riverapes.org) is planning events, some of which appear on their calendar and the TEHCC calendar. COVID-19 distancing guidelines will be followed. Contact Andy Steffan for information.

Tennessee License Plate Grant Provides New Saws

TEHCC received a 2020 Tennessee Appalachian Trail License Plate Grant to purchase a 16-inch Dewalt battery-powered chainsaw, several batteries, and two Silky Katanaboy saws. The chainsaw is expected to replace several 35-year old chainsaws (16" bars) with a lighter and more reliable solution. Technical improvements have brought these saws to the point where they may be effectively carried and used away from home and the trailheads. Gone are the challenges of starting the saw in the field and carrying bottles of fuel. Bar oil is still required. Even with extra batteries, the saw and its accessories are lighter than the old gasoline saws it replaces. This electric saw is only for use by our certified sawyers.

The two Katanaboy saws will add to the handsaws available to maintainers when they are working on the Trail. The current saws are popular, as the demand out-strips the supply. Being light weight and easy to use, many blowdowns may be safely cleared without the need of a separate trip by a sawyer.



Laurel Run Park, Saturday, July 18, 2020

Rating: Roughly 4-4.5 mile round trip with 600' elevation change and one stream crossing

Our gathering point is at the back of the park (364 Laurel Run Park Rd, Church Hill, TN 37642) with the shelters, at the trailhead at 9 am. Hikers will first enjoy the new footbridge over Laurel Run built as an Eagle Scout project by Nathan Michalik of BSA Troop 48 (news report). The group can choose whether to take a steep loop up to Canebrake Mountain Overlook for a nice view of the river valley or just proceed up Laurel Run Trail with one stream crossing to see the low waterfall and abandoned homesteads. Bring a hiking stick, drinking water, snacks, bug repellent, and water shoes or sandals for the creek crossing. Plan to be back to the parking lot by noon.

Summary: Starting at the Iron Gate and going northbound, there are two blowdowns that will require a chainsaw. There was previous flooding where the trail dips. This area is now passable and some of the big logs that were previously cut are lying in the trail. Due to all the debris and mud, we were unable to roll them off the trail. About 30 feet from that area is the big blowdown that was reported by a hiker. We cut and removed two smaller trees and some weeds. The trail south of the Iron Gate is still flooded.

We cleared several fire rings between the woods and the barn, and cut back weeds from the FS road/blue blaze intersection up to the A.T. and on the A.T. most of the way up to Little Hump. We picked up about a half bag of trash, mostly around the barn, and also removed a couple of minor blowdowns from the FS road. There were many more hikers than I expected: several section hikers, several thru-hikers, a gaggle of trail runners, and many day hikers. The Roaring Creek Road parking area was full. I will need to return to go over the top and mow around the barn when I can get through the gate.

Purpose: Assess Trail condition

Location: Section 14a, Doll Flats to Bradley Gap

Summary: We hiked in from Little Elk Road to search for endangered species, as I am the new maintainer for this section. We cut out a few blowdowns above Doll Flats before the first fence. At the first fence, Carl headed back and I continued to checkout the rest of the section. I traveled all the way to Yellow Mountain Gap, then returned. Overall, this section is in good condition.

We also checked the narrow ledge. The small hole which has already been reported is still visible, but does not appear to be any larger. Numerous day-hikers from both trailheads were hiking.

Summary: Renee and I finally had an opportunity to inspect our section this spring. It was in better shape than expected; no blowdowns. However, there was LOTS of grass and vegetation to whack. We cut weeds for about 1.5 miles, including the access trail from the barn road to Yellow Mtn Gap. It appears someone has done a little clearing up near the Overmountain Victory southbound trail already. There were about 8 tents near the barn at the end of the day, fairly well spaced, but could have been better. The grass was about 18 inches high, which impeded camping a bit. Overall, we saw at least 40 hikers throughout the day. Most were section or overnighters; at least 4 were thru-hikers resuming their trek one way or another.

Summary: I checked the section, cleaned water diversions, and cut back briars and branches. The section is clear. I saw nine hikers.

Summary: With Cherokee NF now allowing return of section maintainers in small groups, I decided to give the southern 1.3 miles a "good haircut" using a swing blade and loppers. There were clumps of growth pushing the hikers toward the lower lip of the path. I was able to get north to the cut rock steps before lunch, but did not finish heading south from the outfitter before my water ran out and temperatures hit the 80s. For safety, I called it an afternoon. Two trail runners from Old-Timers Hiking Club reported Section 19b was clear, but observed a blowdown a mile south of Indian Grave Gap. Eight backpackers were all NOBO, including the couple who had inquired via the website about trail access.

The trail was gouged north of the first bridge, so I used a hand saw to remove some overgrown rhododendron to open up more of the path, and then hauled rocks from a nearby fire ring to fill in the hole. More fine sand and clay soil is needed to finish the repair, which could be gotten with a shovel and bucket from a filled waterbar just to the north. I returned to the outfitter (which was full of campers from as far as Florida, everyone with a tube, kayak, or raft), and headed south to finish trimming the uphill growth to the cut rock steps before lunch. This portion of the path could benefit from removal of sloughed soil – and by the new hammer drill to cut out some rock. I saw six section hikers and roughly two dozen day folks mostly from the campground. After lunch, I went back to work on pruning the dog hobble up to the first bridge, but gave up as temperatures exceeded 80°F (with the stream and river providing some cooling). Overall, Section 19b is in decent shape.
