

75th Anniversary Incentive for Hiking and Maintenance

In the <u>February 2021 club newsletter</u>, the Steering Committee announced that they wanted to encourage hiking and maintaining the TEHCC section of the Appalachian Trai by providing an incentive of a pint glass sporting the club logo for hiking at least 40 miles on the A.T. or completing 40 hours of trail maintenance (non-meeting) during 2021. **The reward is open to all club hikers and volunteers.** So far, three club hikers have qualified with trip reports in the club newsletter – and another three appear to be working on the hiking challenge. 

Recollections for Club's 75th Anniversary - Trail Relocations

From 2001 to 2014 alone, TEHCC built over 30 miles of trail relocations and completed almost 9 miles of trail rehab. A good example was all the relocations performed from Cloudland to Hughes Gap in the Roans. This project was near the last of our major relocations because it was so difficult. And the club had to gain experience building trail in exceedingly difficult terrain before we could tackle it.

When the Optimal Location Review was done in the early 90's with ATC, US Forest Service and TEHCC members, the steep climb of the Appalachian Trail from Hughes Gap to Cloudland was eroding badly. But the team had no suggested solution.

As the club maintainers gained confidence by 2007, Ed Oliver and Jim Foster spent many days laying out possible switchbacks over much of the terrain by just pushing as far to one side of the ridge as they could before hitting an impenetrable rock formation or rare species. The NEPA process was challenging for the US Forest Service because of the rare plant and animal life on this mountain.

Ed's hand drawn map of the relocations is shown to the left.

In 2010, we started the first digging at Hughes Gap. The organic soil closer to Cloudland was not stable enough to hold a trail; so much of the trail was paved with rock. With sledgehammers and wedges, big rocks were broken and moved. TEHCC used smaller groups, like a dozen from Wright State University and over 120 people each day over four days of Hard Core. In fact, this project was the last relocation done with Hard Core. Also, we had many weekly

outings with just TEHCC. Over those five years, 403 volunteers contributed 11,660 hours to improve the Appalachian Trail – not counting the seven weeks Konnarock Crew invested over three years. Finally, in May 2014, the entire project was finished. So, eight years from the initial flagging and after five years of digging, we had essentially a new trail in this section.

While the club was putting in this effort in the Roans, we also rebuilt Curley Maple Gap Shelter and completed major relocations of the Appalachian Trail at Watauga Lake, Pond Mountain, north and south of Stan Murray Shelter, White Rocks Mountain, Nolichucky Expeditions, Little Rock Knob, south of TN 91, and Backbone Rock Trail.

Now there are about 36 switchbacks from Hughes Gap to Cloudland. The original 2.6-mile trail had become 4.6 miles after we built 3.25 miles of new trail. For years, the hikers who remembered the old trail thanked us for the improvement.

Morgan Sommerville, ATC SORO Regional Director in April 2018 wrote, "Yesterday I hiked from Jane Bald to Hughes Gap. It is the first time I have hiked the Cloudland to Hughes Gap section since y'all finished doing all the relocations. What a great job! Beautifully laid out and great construction throughout. Thanks!"

A.T.: US 19E to Big Hump Mountain, Saturday, April 10, 2021

The hike from highway 19E to Big Hump Mountain took place on a brisk Saturday morning. The temperature at the bottom of the trail was about 60°F, and the wind chill along the trail on the way up made it feel a bit more like a winter hike. Even with the cold weather, early spring seemed to have taken hold on the trail as dense foliage had begun to creep toward the trail. About 3 miles up on the trail, the trail was clouded by a dense cloud/rainstorm making for limited visibility for the rest of the way up to Big Hump Mountain. Despite the non-ideal weather conditions of the hike, the trail remained in good shape with little to no sign of erosion and no obstructions due to fallen trees or overgrown plants. Due to the weather at the top, the hike yielded little reward in terms of a view. Nonetheless, logging 10 miles on the trails is never a bad feeling. The hike ran from about 8:30 AM to about 11 AM. I was the only individual in attendance for the event.

A.T.: Carver's Gap to Roan High Knob, Saturday, May 1, 2021

A.T. Maintenance Reports

Reporting: Vic Hasler **Date:** 4/6/2021

Purpose: TEHCC and CMC A.T. Partnership Discussions

Location: Zoom meeting

People: Dan Firth, Carl Fritz, Vic Hasler

Summary: The two A.T. maintaining clubs held a joint meeting with ATC, SAWS, and USFS (all three districts) via Zoom. A wide range of topics were covered, of which a few key points are shared in this report.

- * Konnarock rehab in Greasy Creek section is happening May 13-20 with half-size paid crew, no Konnarock volunteers, and club volunteers are invited to join.
- * SAWS crew will be working north of Vandeventer Shelter June 23-30 doing tread repair and removing overgrown laurel.
- * Cherry Gap Shelter replacement Funding availability extended until end of 2022. If an existing USFS design similar to Curley Maple Gap shelter can be identified, then already approved even with minor (non-structural) changes.
- * Sawyer certifications have been extended through October 2021. First aid/CPR extended for one year past the card date, but only for prior in-person training. ATC and SAWS may be able to offer sawyer training courses, thus share need to match when openings are available.
- * Fall 2021 Partnership on Tuesday, November 16 (1-5pm).

From the CMC discussion, highlights reported by Carl were:

- * CMC requested language from USFS to add the application of herbicides to their Volunteer Service Agreement.
- * CMC's Check-in/Check-out policy still in development with a flowsheet rather than verbiage.
- * USFS indicates that a future need besides volunteer hours will be trail mileage; however, definition of what is wanted for trail mileage is unknown.

Summary: Ted mowed the camping area while Paul trimmed and dug out some drainages. With the help of Poncho 420, I sawed up all the brush and logs that had been drug onto the open area to provide firewood or benches. He also helped me refasten a leg on the picnic table. We resealed the second floor access with screws and cut down the stair risers. Hikers are cutting up sleeping platform supports for firewood. We cleared all the leaves out of the access road culvert pit. This is a project that needs to be done at least every three years. About six years ago, the road was being washed badly. We could not find the receiving end of the culvert. Roots had grown into the compacted leaves. We eventually found the culvert entrance about five feet down.

Summary: Four wheelers have been going to the Holiday Inn Shelter near McQueen's Gap for many years. Greg and Joe put in posts and log barriers 3 years ago. This didn't deter them much. At the Gap, three steps and ugly rocks were installed in the dirt mound that was put in years ago to divert vehicles. Two-hundred feet up the trail near a tree on the right side beside the ditch, we placed three very large rocks and many smaller rocks. We used the grip hoist on a 2-to-1 pulley to pull these rocks into place. We hope that will deter the four wheelers for now.
