

The 2021 <u>Appalachian Trail VISTA</u> program will consist a set of hikes along the A.T. and nearby trails with photos and videos posted that evening followed by a montage released in October 2021. To keep this event easy/family friendly and examine an excellent feat of wilderness construction, I chose to lead a recommended walk from the <u>Dennis Cove trailhead</u> to Koonford Bridge (as featured in <u>March 2021 club newsletter</u>) and back. The path is a level rails-to-trail conversion except for the last short section down to the stream and bridge. This hike will not visit Laurel Falls with its many rock steps from this direction.

After the hike, we can relocate the group to <u>Shook Branch Recreation Area</u> on Watauga Lake to enjoy the picnic lunch everyone brings for themselves. (Park has bathrooms.) We can also check out one of the club's newest bridges constructed nearby.

The caravan will leave Colonial Heights Ingles parking lot by 9am to arrive at the trailhead parking area around 10am. (Alternatively, just meet there but let us know you're coming!) The hike will be roughly hour and half including time to possibly toss rocks into the stream. The picnic area is 15 minutes away from the trailhead, and then we'll stay as long as the group decides. Recollections for Club's 75th Anniversary - Canoeing

When Frank Oglesby convinced Tennessee Eastman Recreation that an outdoor club should be formed, the first focus was hiking trails in the area. However, by the start of 1970s, canoeing trips on regional rivers were being posted in the TEC News company newsletters. Merton Dibble and Jim Crowell were guides for expeditions on the Watauga River, Nantahala River, and others.

TEHCC unofficially adopted the Nolichucky River as the club's river in the early years. Many trips were on the lower Nolichucky from Nolichucky Expeditions above Chestoa down to the Big Rock Rapid. Regular clean-up events have also been organized for this river.

Canoe School was initiated in 1973, also known as "Introduction to Whitewater Clinic" starting around 2003, with an evening of classroom instruction and two days of instruction on the Nolichucky River. Instructors have included Rick Phelps, P. Darling, Terry Dougherty, and Mike Morrow.

Another favorite local river of TEHCC was the Hiwassee River as Tom Pridgen and Ed Montgomery led many trips.

Beginning in 1979, Terry Dougherty has led a long-running (now 40 years) series of weekend outings to enjoy the Bluestone River in West Virginia – staying in the Mountain Creek Lodge in beautiful Pipestem State Park. Paddling runs range from Class I-III on depending on section and water flow during the weekend. Ed Montgomery has hosted the trip's Happy Hour for many recent years.

The club has paddled rivers across the nation in Maine, Florida, Texas, Utah, Idaho and Montana. The San Juan in Utah was among the club's favorite out West. In addition to river paddling, many trips were led in the Boundary Waters Canoe Area in Minnesota.

Another significant event for this recollection is the formation of the Appalachian Paddling Enthusiasts (APEs, riverapes.org) club in

1986, who focus on enjoying and protecting rivers in northeast Tennessee, southwest Virginia, and northwest North Carolina. While a kayak is more likely to be used than a canoe on whitewater, the club supports all types of human-propelled craft on area waters. This relationship has evolved so that Andy Steffan currently serves as our TEHCC Liaison with the APEs organization, since the latter arrange the river trips now published in the club newsletter. Starting in 1999, a joint winter pitch-in dinner is hosted by both clubs at the Eastman Lodge where whitewater videos and paddling gear are shared. APEs regularly put on training for Beginning Whitewater Kayak and Swift Water Rescue plus host Wilderness First Aid courses. Another example of this partnership is the Green Bridge Landing Changing Station, built in 2019, in a park on the Lower Doe River in Hampton, TN (see November 2019 club newsletter).

A.T. Hike: Carver's Gap to Grassy Bald, Saturday, June 26, 2021 Chantel Roberts reporting





It was a sunny Saturday morning as we met at the Carver's Gap parking lot in Roan Mountain Park. The weather was initially calling for clouds, but it ended up being completely clear! I'm glad we got there early because the parking lot was already almost full at 8 am. We set out climbing the trail up to the first bald. There were several types of wildflowers blooming, including flame azaleas and gray lilies. The views were incredible, with several layers of ridgelines visible on either side of the trail at the three balds (Round Bald, Jane Bald, and Grassy Ridge Bald). This trail is very popular, so we passed many groups of people on sections of narrow trail. We also saw several tent campers along the trail. We summitted Grassy

Ridge Bald about 2 hours after starting, at an elevation of 6189 ft! Grassy Ridge Bald is one of the highest grassy balds in Appalachia. Total mileage was around 5 miles, along with 1100 ft of elevation gain. The group took about 3 hours to hike the 5 miles, with plenty of stops for snacks and water.

Summary: I walked through the section. Gloria shuttled me. I checked to see how high the grasses and roses had gotten; they are plenty high in spots. I cut back vegetation as needed. I found a new campsite with a large stone fire ring in the open field area. The post next to it was covered with duct tape for some reason. I broke the fire ring apart. I was looking for a reported large downed tree, but the section was clear. It was good to run into an old forest service friend, Ruben. He reported seeing a sign at the top of Bishop Hollow; I said I would take care of it. I found a sign for a hostel at the upper end turn, removed it, then hiked on up to the gate on Roby Miller Rd. I found what looked like a blue blaze on the FS gate post and another wooden blue blaze on a bearing tree. Since the club would be here the next day, I walked Roby Miller Rd, clearing vegetation to make it easier for the trucks. I also checked for more blue blazes. I found some, but they are outside of forest service property. I then returned to the trail. I saw a lot hikers, thru-hikers, section and day hikers. I got to the car just as storms rolled in.

bridge and removed trash and an abandoned tent from the same area. There were shoes, a very dirty sleeping bag, and food trash in the tent. We also rehabbed a section of trail just south of there by extending a turnpike by about 6 feet and refilling the existing turnpike with mineral soil. We also added a couple of stepping stones outside the south end of the turnpike to address muddy conditions.

Summary: It rained, then it rained some more and then it rained hard. We started off intending to hike to the shelter, lopping along the way. There was a report of a blowdown near the shelter, which I thought we might be able to get. Unfortunately, the rain continued to increase and we started to hear thunder.
