Letter from the Chair

I had the opportunity to take one of our new kayaks out for a paddle on the river just north of Boone Lake from Winged Deer Park, which was a great time! We even had a heron fly right overtop and land nearby, seeming to be unbothered by our presence. We gave it some space and watched for awhile before paddling on. Since the club has recently gotten boats, I believe I saw a recent Virginia regulation update. Beginning in July of this year, anyone that uses a state constructed boat launch on a river will have to buy a user license from the state, regardless of the size of watercraft (including boats, kayaks, canoes, etc.). These licenses can be bought online for \$4 for a single day license. Year-long licenses are also available. Virginia hunting and fishing licenses also function as user licenses. I just don't want anyone to get in any unexpected trouble! This only applies to Virginia, not Tennessee.

Also, I want to continue to encourage everyone to join our club-led hikes and maintenance events, with the incentive that you can earn a pint glass. You can reference previous newsletters for more details.



4000th Patch Issued to First-Time "Hiker-Trail Volunteer"

Tennessee Eastman Hiking and Canoeing Club have had very active outreach programs to win the hearts and minds of hikers and college students towards future trail and recreation work. Many maintainers, like Bob Peoples and Bill Stowell, were early significant recruiters. In 1998, thru-hiker Marty Allen,"The Artist," designed a "Hiker-Trail Volunteer" patch depicting a crossed crosscut saw and mattock superimposed over Laurel Fork Falls. It was lettered by thru-hiker Sara Allen,"Rosey." We started issuing these patches in 1999 to any first-time, non-Club member who made a significant contribution (usually one work day) to A.T. maintenance. In this, the 23rd year, we issued our 4000th patch on June 5th when seven new volunteers from the community came to support a Saturday outing to cut rhododendron. It was National Trails Day!





Another major outreach program we ran for 15 years through 2015 recruited hikers for two days maintenance as part of Damascus Trail Days. This program was initiated in 2001 and became known as Hard Core. All first-time participants earned a Damascus Hard Core patch rather than the Hiker-Trail Volunteer patch. Many participants had worked with Hard Core in previous years, so they received a rocker patch. In the fifteen years of this program, we recruited about 738 first-time maintainers in this program.

In these two programs we have recruited almost 4740 first-time maintainers in 23 years. These first-timers on their first day contributed over 35,400 hours. Fifty-nine percent of these first timers were college students, 36% were hikers, and 9% were others (boy scouts, venture scouts, high schoolers, or

local volunteers). College students have been primarily from four universities, Appalachian State, Wright State, East Tennessee State, and University of North Carolina-Charlotte. For many of the college students, this was their first exposure to the Appalachian Trail. Likewise, most hikers and college students experienced trail maintenance for the first time.

As we started major trail relocations, opportunities for recruiting increased. We ramped up from about 90 first-time volunteers each year to almost 400 by 2006. As those large projects were completed over the next decade, the number declined to about 80 per year, which we hopefully can maintain with routine maintenance and rehab.

We plan to continue to share trail maintenance with hikers and students. The patches are very meaningful to many. The hikers usually sew their patches on their pack that evening. The patches symbolize their giving back to the trail!

A.T.: Uncle Johnny's Hostel to View Over Nolichucky, July 8, 2022 *Kyle Haas reporting*

The initial goal was to be able to make it to Woody's Ridge, which is a very difficult hike located in the Black Mountains. The hike began with wonderful temperatures and the whole parking lot to ourselves. Unfortunately, since we were the first ones on the trail, it meant we had a lot of spiderwebs to plow through, but I took one for the team. We saw plenty of mushrooms and wildflowers on the way up, more than I expected for this time of year. The trail was overall in great condition, with only one spot where a small tree was across the trail, which I notified our maintainers of afterwards. Summary: What started out to be a travel day for work, turned out to be a trail maintenance day. My flights got delayed about 12 hours and the forecast for this coming weekend looked bleak when I was going to do some trail maintenance; so I took the opportunity to be on the mountain for a few hours.

The gravel road up Roaring Fork Valley has been significantly improved; I guess by the county. The one really bad spot with lots of large rocks is almost a non-issue now; just a minor slowdown. I arrived at the gate early. Spent about 15 minutes knocking down the high weeds and a few limbs that were encroaching the road. Upon finishing, I looked up and there was a large blowdown about 100 yards ahead. Thankfully I remembered to bring my saw today. I knocked that out in about 15 minutes getting some weightlifting in for the day. While dealing with the blowdown, I met some hikers that were happy to get a lift up to the barn, so I obliged. By 8:30, I was loaded down with fuel and water and headed up the hill.

I cut weeds with the big boy Stihl brushcutter, complete with harness. I started at the Litte Hump clearing. Everything to this point was in decent enough shape to wait until I had more reinforcements. I was able to weed continuously almost all the way to Bradley Gap. I had to stop a couple hundred yards short due to a disagreement with the Stihl. Bradley Gap was strangely dry. Very surprising given how much rain we've gotten. The future bog bridge area was easily walkable with no mud. Upon returning to my orange foe, it gave into my will and started again. I was able to weed the other side back to the top of Little Hump until I ran out of fuel... four tanks. Grass at the barn was pretty short. I'll come back in a couple weeks to mow and bring reinforcements to finally knock all the weeds back really good until we hit them again before winter.

I'd like to move forward with putting up fiberglass sign posts in the open areas to replace the rotting fenceposts. We'd probably need about 20-25 for this section; probably 30+ if we want to do that on Big Hump also.

Summary: Overall, our designated 134 miles of the Appalachian Trail remain in good condition with prompt removal of reported blowdowns and steady improvement of the tread. Upcoming trail maintenance projects were discussed to ensure the plans were appropriately developed, including Wright State University student trip, bog bridge for Bradley Gap, Saturday crew, etc. For 2023 there are other bog bridges/turnpikes to replace, which could involve local locust or building from treated lumber; thus candidates

for a license plate grant. The Roan Mountain visitor use management initiative was discussed. Desired 2022 goals are refreshing the campsite inventory and investigating where the A.T. should lay. Cherry Gap Shelter replacement proceeds with an agency visit this fall and NEPA review in 2023. The next committee meeting is tentatively set for October 10th.

Purpose: Survey multiflora rose for future eradication

Summary: Jones Bog located on the Shady Valley side of the trail is a biologically diverse and important area. Previously, a homestead was located just below the trail creating a disturbed area allowing multiflora rose to become well established and abundant in the area. I surveyed multiflora rose with Michael Kochinski (intern with ATC) from the trail down through the bog, so that a management plan may be submitted to the Forest Service with the goal of eradicating the multiflora rose.

Purpose: Remove blowdowns

Location: Section 16a, Greasy Creek to Clyde Smith Shelter

Summary: A hiker had reported a fallen tree about a mile south of Clyde Smith Shelter. The report was off by about a mile, but it was closer for me since I came up by way of Greasy Creek Friendly Hostel. The downfall was a live wild cherry tree, apparently blown down. Hikers were able to struggle through the branches of the top of the tree. The main trunk was only about 4 inches and another branch was about 3 inches pinned to the ground, so it had to be cut from the ground up. Branches were first pruned off and then trunk was cut. The cut was somewhat difficult from binding from the fresh wood grabbing the blade, but it took only an hour to cut and clean all slash off the trail. Then I proceeded to Clyde Smith Shelter to inspect the trail for more downfalls and snip branches hanging over the trail at eye level. I met 5 hikers that were spending the night at the shelter. I removed some trash, as well as took trash from the hikers and returned to Greasy Creek Friendly just before dark. The trail from Greasy Creek Friendly Hostel is pretty rough and could use some help because of washing out and no water diversions to speak of. All the hikers at the shelter were friendly and I enjoyed chatting with them. One other thing to note is there is a bald faced hornets nest about 1/2 mile from the shelter that is about 7 inches in diameter and about 3 feet from the trail. I was hiking with a couple that I met just as I was finishing up clearing the tree. He stopped to take a pic which I advised against, but he did anyway. He took the shot from about 4 feet away. One hornet crawled out and watched and I was glad it stayed there. I wonder why the nest is so close to the ground where it would be a danger to hikers.


