### South Holston Spillway Trail, Saturday, November 5, 2022, 9:30 am - 11:30 am

Rating: Easy, ~3.5 miles, 450' elevation gain

Location: South Holston Spillway Trail Parking Area, S Holston Dam Road, Bristol Tennessee 37620

Looking for a nice, relatively easy, wide gravel trail that's relatively close-by in Bristol? Here's a great opportunity to join the club on a fairly short hike to a view of the South Holston Lake and surrounding mountains. We will travel approx. 3.5 miles (total) on this out-and-back trail through the woods until we reach the clearing at lake level. Bring some water and a few snacks! Optional if

people are interested is to tack on the very easy Osceola Island loop on our way back to see neat fishing weirs and great views of the river (< 1.5 miles).

**Driving directions**: On I-81, take exit 69. Turn right (east) onto TN 394 for 12 miles, which goes past BMS. Turn right (south) onto US 421 and travel 3 miles. Turn right (south) onto Emmett Road (South Holston Dam sign) and travel 1 mile. Veer right (south) onto Holston View Dam Road. Continue past Osceola Island parking area. Near the base of the dam, take sharp right onto S. Holston Dam Road. Pass picnic area on left. Parking is a small gravel pull-off (for about a half-dozen cars) on right before reaching the top of the dam.

### Devil's Bathtub, October 15, 2022

He then removed dirt from the rear and sides of the shelter to allow for better drainage and dug a drainage ditch on the left side of the shelter. He used the dirt to fill the rutted section of the trailbed south of the shelter (70 feet total). He also covered some exposed roots in trail north of the shelter.

**Summary:** Ed installed a "NOT A.T." sign at the entrance to the north field of Osborne Farm. Some NOBO hikers do not see the third stile on the farm. (Thanks to Carl for making the sign!) Ed cleared the trail to the shelter and removed a recent and an old blowdown. He inspected the shelter and spring, and placed flat stones under the legs of the shelter picnic table. He removed more dirt from the right side of the shelter and dumped it on trail both south and north of the shelter. He cleaned a waterbar just north of shelter, and used a wheelbarrow to haul rocks to the 2.4-mile mark south of shelter and began building stone cribbing.

**Summary:** On a beautiful cool day with some frost, we rehabbed south of Hughes Gap. We also removed an 18" blowdown and cleaned/enhanced some water diversions. We installed 30 feet of side logs to bury roots, and dug another 120 feet of roots and buried more. We also added 7 rock steps and 3 stepping stones. Van cut another 18" old blowdown that was sticking into newly dug trail.

Summary: I went in again via the new access point to recheck the wet areas for future maintenance and to do some lopping. The worst of the wet areas span about 1/2 mile and are easily accessible via the new access point. It would add about 0.35 of a mile of bushwacking. I've added a video to YouTube (mountainsquid04) highlighting the wet areas and the possible location of some locust logs just south of the wet areas. Some sort of bridges are probably necessary. While scouting things out, I encountered and removed two blowdowns. I was also hoping to discover a different way back to the dirt road. Twice I was waylaid by too many rhodos blocking the way.

**Summary:** The crew helped install the long-awaited Peakfinder signs on Round Bald. The acquisition of the signs was initiated by SAHC and paid for with a grant from ATC. The USFS assisted with the transport of materials to the work site. We also installed an "experiment" using Parmak Step-In Pigtail Posts and polypropylene rope creating a corral around each Peakfinder. Part of the crew ventured out to the summit of Grassy Ridge and installed the summit sign. A large contingency of day-use visitors were present on a fantastic day in the Highlands.

Laurel Fork Gorge was spectacular with color, including the falls! On the blue-blaze trail there are several new signs. Unfortunately, they are not in the ground very well; they are very loose and can be lifted right out. I'd be surprised if they remain much longer. Thursday crew? or at the very least, let Forest Service know, before they end up in someone's basement. It was a great day with lots of hikers enjoying the falls. I gave out one patch.

**Summary:** It was an awesome day to be out. Gloria shuttled me and helped a bit before leaving. I never know what I might find in my section. Today it was a gutted deer in a large garbage bag, probably thrown over at Bear Branch Rd. It rolled down, ripped open, and landed in the middle of the trail. With the rotting remains intertwined with the bag, I managed to roll it off trail down hill.

Now back to our normal trail stuff. I cleaned 20 waterbars, and added 3 waterbars and a step, some from a saved locust tree. I also added a stone step, cut vegetation as needed, broke up a campfire ring, and cut a few small blowdowns with hand saw. I'll have to come back with chainsaw to get 3 more. They aren't much of a problem for hikers to get over right now. I met about 16 section hikers on the trail.

**Summary:** We removed several small blowdowns, cut back vegetation, and picked up trash by the shelter. Two issues will require follow up maintenance. First, a very large oak, approximately 3 feet in diameter in a very steep area is very difficult to get around. It broke off from the roots, so nothing is holding it above. It appears it will slide when cut. We will need the cavalry for this one. It is approximately 2 miles in from DevilsGgap. Second, the table at the shelter needs repairing again. The side board holding the seat rotted out and the two boards (seats) fell off. We think it can be repaired, but will need two 2x6, 8 feet long. The actual seats should be good to use again.

They reported a couple more issues which we decided to tackle at a later date.
