## Letter from the Chair

Hello friends.

Welcome to the flowers of May! One of the best parts of hiking is discovery. Discovering new areas you haven't seen, discovering your own limits, and discovering a community of like-minded adventurers. While these are discoveries you will carry with you the rest of your life, the other discoveries should be left on the trail - such as flowers. This month we will discuss one of the seven principles of "Leave No Trace" called *Leave What You Find*.

Letting the flowers and local vegetation stay in place is a responsible way to ensure the continued longevity of the species and its impacts on the ecosystem. Leaving no trace includes the marks we leave intentionally and unintentionally. This means not carving initials into trees or driving nails into them, not digging unnecessary trenches, and leaving the natural landscape undisturbed. The importance of leaving what you find is deeper than just making sure others get to discover it. It is important to ensure the local wildlife have much-needed resources such as dried leaves for nutrients and vitamins. Moving rocks to make fire rings is a great way to protect the surrounding area from human impact; but to further reduce the impact we are encouraged to replace the rocks unless it is a designated single fire ring. A fire ring may not be necessary, as a stove eliminates the need to burn things, especially where fuel supply is limited, like in the Roan Highlands.

An alternative to taking what we want from the forests is to take pictures or practice sketching. Not only does this allow others to enjoy the natural beauty, but it also helps you develop an artform and a sense of introspection. By being responsible stewards of nature and leaving it as we find it, we ensure that it can continue to flourish without disturbance.

## Carver's Gap to Roan High Knob, Saturday, May 20, 2023, 9:30 am - 12:00 pm

Location: Carver's Gap Trailhead, Tennessee 143, Roan Mountain, TN

This hike follows the A.T. west from Carver's Gap, ascending Roan High Knob through a lush, green, shady forest filled with balsam fir trees, fern, and moss. The hike passes the Roan High Knob Shelter, the highest-elevation shelter on the entire Appalachian Trail. Passing the summit, the hike veers off the A.T. to visit a high elevation overlook, catching exceptional views near the former site of the historic Cloudland Hotel. We can extend this hike for 2.4 miles to Roan High Bluff or in the opposite direction from the trailhead to Round Bald/Grassy Ridge Bald/Jane Bald if the group desires more mileage. Weather permitting. Dogs welcome on leash. It's recommended to bring plenty of water and snacks. Limited to 15 people.

## Tim Stewart - SORO Club Volunteer of the Year

For his commitment to the Appalachian Trail, TEHCC is excited to share that Tim Stewart was elected by the five Southern Region A.T. clubs as the 2023 Volunteer of the Year.

Our story for Tim Stewart begins with his retirement from the US Navy, when he section-hiked the Appalachian Trail to become a 2000-miler with trail name of Mountain Squid. Tim joined the TN Eastman regular crew as the club was building the Mountaineer Falls Shelter in May 2006. From that day, Mountain Squid's involvement with TEHCC reached 6,253 career maintenance hours by the end of FY2022; thus averaging roughly ten full-time weeks annually on the Appalachian Trail over 16 years. He has been the designated section maintainer for 6.9 miles of the A.T. backcountry from Canute Place to Bitter End. And Tim now leads the club's Second Saturday "Hiking with Tools" introductory trail maintenance, as shared elsewhere in this newsletter. He is kind and generous with his time, showing new maintainers the details of their adopted sections.



Tim is our club's representative on the Tennessee A.T. license plate committee, which reviews grant requests and approves the most appropriate for funding. He is an active participant in the Roan Highlands Visitor Use Management effort, now underway. Tim also serves as a moderator for WhiteBlaze.com, and its guidebook. # A.T. Vista: August 4 - 7, 2023

The A.T. Vista program (atvista2023.org), based out of East Tennessee State University (ETSU), is a long weekend offering excursions, exhibits, hikes, workshops, and two dinners as the region celebrates the Appalachian Trail and other outdoor opportunities. Early Bird tickets for admission to all events are available through May 31st at \$100 adults, \$50 youth (ages 16 & under). Currently, almost 100 folks have signed up towards the goal of 400 participants. Excursions (including biking, caving, guided fishing, hiking with llamas, kayaking, and rafting) have already been published on-line for registering directly with the outfitters. # A.T. Maintenance Reports

## **Five-Year Volunteer Service Agreement Signed**

Our next five-year VSA with all three ranger districts has been signed, and is now effective. Its purpose is to establish our mutual understanding of administrative and safety expectations, thus volunteers contributing under this agreement will be covered by federal workers' compensation under the Volunteers in the National Forests Act of 1972 (VIF). Key aspects are:

- TEHCC establishes an annual work plan with the USFS.
- All maintainers are expected to follow safe practices and wear proper Personal Protective Equipment (PPE) which is listed on the back of TEHCC's Release Form.
  - o Boots, work gloves, long pants and hardhats are recommended or required for most tasks.
- Tailgate meetings to describe tasks are to be performed before you start work.
  - A list of all club members and volunteers during 2022 was submitted for the VSA; however, sign the trip roster to acknowledge the tailgate meeting.
  - New or one-time volunteers are covered by signing the roster on TEHCC's Release Form before working.
- A basic first aid kit should be among the crew.
- Follow check-in / check-out guidelines.
  - o Provide trip details, including parking location and expected time of return, to a trusted point-of-contact.
  - Once out of the field, check out with point-of-contact.
  - o If point-of-contact does not receive check-out notification and cannot contact trip leader after a reasonable amount of time, club representative should be contacted.
- Anyone under age 18 will need to have parent/legal guardian approval before performing any volunteer service.

Be safe by following the expectations so that no injuries occur, and compensation is never required.

Renee also painted needed double blazes near both Sugar Hollow and the Elk River access point.

**Purpose:**Finish rehab at Splash Dam Falls

Summary: We finished rehabbing the trail near Splash Dam Falls. The ATVs and monster trucks had done a lot of damage to the trail. With having no Forest Service Law Enforcement Officer, we decided to widen the trail so they can go by the A.T. We had a large blowdown north of the trail and, because of the vehicle traffic, chose to put a step-over rather than clear the blowdown. We rehabbed 135 feet of trail at 4 different spots. We screwed the sidelogs to their stakes to make it difficult to remove the sidelogs. Large drainage ditches were dug to insure that water drains out of the area. It was a beautiful day to be outside. **Summary:**This was a general maintenance trip to survey spring conditions. The rhododendron are encroaching in many areas. I spent the bulk of my time trimming them back off the trail in anticipation of the spring growing season. A second trip will be required as only the upper half of the section was addressed.

**Purpose:**Clear blowdown and repair roof on Abingdon Gap Shelter **Location:**Section 2b, McQueen's Gap to Abingon Gap Shelter

Summary: This was the second trip to check the shelter roof for reported leaking by slinging several gallons of water at the roof gap. On the previous day we determined we did not have the right material to fix the roof. Whoever repaired the roof the last time used expanding foam which was apparently failing due to deterioration from age. I applied a stream of the foam all the way across the front and back of the roof cap and pushed it under the roof cap with a putty knife as I went. I can only figure the rain was being forced by wind through cracks in and around the foam where it ran down the inside of the roofing and dripped onto occupants in the shelter. The last application of the expanding foam had been trimmed flush with the cap which may have added to the problem by cutting the seal of the foam. It hardens to a slick shell on the outside of the foam with the inside not being sealed since it was trimmed. I doubt this would be a problem if storms were not blowing up under the roof cap. If the leaks are not due to the force of the wind blowing under the roof cap then it may be that the occupants in the shelter were receiving rain that was possibly being blown against the back and sides of the shelter as it was running off the roof. From there it could be blown in a spray over the walls and into the shelter. The remendy for this problem may be to add gutters so the water coming off the roof won't be as likely to be blown over the wall, or add flashing around the walls. This is speculation because I inspected all nails and could not find any nails that were loose enough to let in but a minute amount of water. I know the way I applied the foam is not pretty but I recommend not cutting it flush with the roof cap to avoid breaking the slick seal of the foam and therefore letting water blow around the foam. (It was fairly flush when I applied it, but expanded out from under the cap.) I think it's really unlikely for the seal to deteriorate so easliy although the previous application of foam was only about half an inch thick or less and came out easily. I recommend guttering to alleviate this problem. Sorry for the long explanation but I can't find a likely explanation for leaks. There is no rusting through of the roof and no holes that I can find. To add insurance to the nails, I applied some foam to some suspect nails. If it continues to leak, something like tar on every nail may be in order.

We removed a blowdown on the return trip to McQueen's Gap where we were parked.



On the log steps, there were several spots where water was pooling right behind the step. I wasn't seeing a way to "fix" that. But maybe it doesn't need fixing - it wasn't a lot of water. There's a blowdown just north of Ash Gap that's easy to step over, so I didn't try removing it. A larger one, just south of Cloudland, covers about half the trail; it probably wouldn't hurt for someone with a bigger saw to go ahead and remove it (I cut off side branches and such). There was minimal trash in the fire ring at Ash Gap. Overall, the segment doesn't look like it's had much use this season. I saw several section hikers and a few thrus. The most interesting one, "Will Rogers," is 74 and enjoying his hike (though he said he could do with fewer

"dope-smoking, potty-mouthed" young hikers). He asked how to get to a hostel so he could attend church on Easter Sunday; I recommended he call Mountain Harbor when he got to Carvers Gap. I look forward to returning on a warmer day in June...
